In exercise of the powers conferred under sub-section (1) of Section 33 of Town and Country Planning Act, 1971, (Act No. 35 of 1972), the Commissioner of Town and Country Planning, Chennai in his proceedings Roc. No. 14363/2008/DP2, dated 8-7-2009 proposes to make the following sanctioned to the Kathalampatti Town Planning Scheme, G.O. Ms. No. 4010, Health Department, dated 24-11-1950 of Virudhunagar Local Planning Area and Published in the *Fort St. George Gazette* No. 48-A, Supplement to Part 1-A, dated 5-12-1950.

2.
