Consequent upon declaration of inclusion of the name of Smt. V. Jayashree as unconditional in the Select List of 2008 by the Union Public Service Commission, as communicated through its letter dated 23rd June 2009 and in continuation to Order dated 8th September 2009 of the Hon'ble Central Administrative Tribunal, Madras Bench in M.A. No. 330 of 2009 in OA. No. 441 of 2009 through which the Order dated 8th May 2009 of the Hon'ble Central Administrative Tribunal, Madras Bench in OA. No. 441 of 2009 has been vacated through which the Hon'ble Court had ordered to keep the remaining post in the Tamil Nadu Cadre of IPS vacant till the disposal of the OA and in pursuance to Order dated 10th November 2009 of the Hon'ble Central Administrative Tribunal, Madras Bench in O.A. No. 968 of 2009 through which the Hon'ble Court has ordered for appointment of the officer to Indian Police Service by promotion from Tamil Nadu Police Service from the Select

List of 2008, the President, in exercise of the powers conferred by sub-rule (1) of Rule 9 of the Indian Police Service (Recruitment) Rules, 1954, read with sub-regulation (1) of Regulation 9 of the Indian Police Service (Appointment by Promotion) Regulations, 1955 is pleased to appoint Smt. V. Jayashree (D.O.B. 19-12-1966), a member of the Tamil Nadu Police Service to the Indian Police Service on probation and to allocate her to the Tamil Nadu Cadre under sub-rule (1) of the Rule (5) of the Indian Police Service (Cadre) Rules, 1954. The appointment will take effect from the date of issue of this notification.

The aforementioned appointment will be subject to the result of the Civil Appeal [SLP (C) No. 2459/2006], pending before the Hon'ble Supreme Court and O.A. No. 929 of 2008 pending before the Hon'ble C.A.T., Chennai Bench.
