ANIMAL HUSBANDRY, DAIRYING AND FISHERIES DEPARTMENT

Amendment to the Special Rules for the Tamil Nadu Animal Husbandry Service.

[G.O. Ms. No. 143, Animal Husbandry, Dairying and Fisheries (AH-7), 27th November 2009.]

No. SRO. B-88/2009.—In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India, the Governor of Tamil Nadu hereby makes the following amendment to the Special Rules for the Tamil Nadu Animal Husbandry Service (Section 2 in Volume II of the Tamil Nadu Services Manual, 1969).

2. The amendment hereby made shall come into force on the day of 27th November 2009.

AMENDMENT

In the said Special Rules, in rule 9, for sub-rule (c), the following sub-rule shall be substituted, namely:—

“(c) Every person appointed by direct recruitment to a post in Class IV shall, undergo the Foundational “A” course training, for a period of not less than eight weeks at the A and B wing Foundational Course Training Institute of Anna Institute of Management, Chennai and pass the examination conducted at the end of the training within the period of his probation and every person appointed to a post in Class V shall undergo the Foundational ‘B’ Course training for a period of not less than three weeks at the A and B wing Foundational Course Training Institute of Anna Institute of Management, Chennai and pass the examination conducted at the end of the training within the period of his probation.”

Amendments to the Special Rules for the Tamil Nadu Industries Service.

No. SRO B-89/2009.—In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India, the Governor of Tamil Nadu hereby makes the following amendments to the Special Rules for the Tamil Nadu Industries Service (Section 19 in Volume II of the Tamil Nadu Services Manual, 1969):—

2. The amendments hereby made shall be deemed to have come into force on the 27th July 1976.

AMENDMENTS

In the said Special Rules.—

(1) in rule 1, in category-3, after the category of officer “Principal, Institute of Tool Engineering, Dindigul” the following category of officer shall be inserted, namely:—

“Personal Assistant (Administration) to the Principal Technical Training Centre, Guindy”;

(2) In rule 2, in the Tabular column under sub-rule (a), after the expression “Public Relations Officer, Information Officer, Information Section, Guindy.

Personal Assistant (General) and Personal Assistant (Cottage Industries) to the Industries Commissioner and Director of Industries and Commerce, in the first column, the following expression shall be added, namely:—

“Personal Assistant (Administration) to the Principal Technical Training Centre, Guindy”,

(3) in the Annexure in the Tabular Column, after the expression “Personal Assistant (General) and Personal Assistant (Cottage Industries) to the Industries Commissioner and Director of Industries and Commerce, Chennai in the first column the following expression shall be added, namely:—

“Personal Assistant (Administration) to the Principal, Technical Training Centre, Guindy.”

2. The amendments hereby made shall be deemed to have come into force on the 10th September 1984.

"Assistant Director of Industries and Commerce (Non-Technical), Industrial Escort Service."
