Notice is hereby given that an election by postal voting is to be held for electing one Professor to the Senate of the The Tamil Nadu Dr. M.G.R. Medical University, Chennai, as per clause (d) sub-section (3) of Section 18 of the Tamil Nadu Dr. M.G.R. Medical University, Chennai, Act, 1987 (Tamil Nadu Act 37 of 1987) by the Teachers of all affiliated Pharmacy Colleges from among themselves to fill up the existing vacancy. The term of elected member will be for a period of three years or so long as they hold the post of Professor of an affiliated Pharmacy College, whichever is earlier.

2. Form of Nomination papers may be obtained from the Registrar In-charge, who is the Returning Officer on or before 7th April 2010 between 11-00 a.m. and 3-00 p.m.

Nomination paper shall be enclosed in an envelope addressed to the Registrar In-charge/Returning Officer and superscribed "**Nomination for election to the Senate from Pharmacy Colleges**" as indicated below, and sent by Registered Post Acknowledgement Due so as to be received by the Registrar In-charge/Returning Officer not later than 4-00 p.m. on 7th April 2010 or delivered to the Returning Officer during office hours in person or by his/her proposer or by messenger under acknowledgement within the date and hour mentioned above.
