No. II(1)/CTR/18/2010.—In exercise of the powers conferred by sub-section (3) of Section 30 read with Section 88 of the Tamil Nadu Value Added Tax Act, 2006 (Tamil Nadu Act 32 of 2006), the Governor of Tamil Nadu hereby makes the following variations to the Commercial Taxes Department Notification No. II(1)/CT/71(b)/2004, dated the 29th October 2004, published at pages 1 and 2 of Part II—Section 1 of the *Tamil Nadu Government Gazette*, Extraordinary, dated the 29th October 2004.

VARIATIONS

In the said Notification,—

(1) against the item "(2) fishermen having country boats fitted with Diesel Engines", for the expression "Forty Five Thousand Six Hundred Kilo Litres per annum", the expression "Fifty Four Thousand Seven Hundred and Twenty Kilo Litres per annum" shall be substituted;

(2) in the 'Form of Declaration', under the item "(II) For Country Boats fitted with Diesel Engine-Category:", in the first column "Quantity of Diesel authorized by the Government per annum", for the expression "45,600 kilo litres" the expression "54,720 Kilo litres" shall be substituted.
