No. 56019/91/DP2, dated 9th January 1992 and published in *Tamil Nadu Government Gazette*, (Issue No. 10), Part VI—Section 1, Page Nos. 274 and 275, dated 11th March 1992 in Publication No. V1(1)/366/1992 and the said draft notification published in *Tamil Nadu Government Gazette*, (Issue No. 27), Part VI—Section 1, Page 276, dated 11th July 2007 in Publication No. VI(1)/359/2007.

Since no objections and suggestions have been received on this draft notification within the stipulated time, the same are hereby confirmed and ordered as below:—

CONFIRMATION OF VARIATION

1. The entire Thuraiyur Detailed Development Plan No. 5 of Thuraiyur Local Planning Area Approved by Director of Town and Country Planning Proceedings in Roc. No. 56019/91/DP2, dated 9th January 1992 is varied by the Director of Town and Country Planning *vide* Proceedings in Roc. No. 24179/03/DP3, dated 18th June 2007 of Thuraiyur Detailed Development Plan No. 5 of Thuraiyur Local Planning Area.

2. The plan thus varied is numbered as "Map No. 5 DDP(V)/DTCP No. 20/2007" and

#### **Arrangements made by Sessions Judge, Chennai Division, Chennai for attending Urgent Criminal Matters during Summer Recess, 2011.**

1. In exercise of the powers conferred under Section 10(3) of the Criminal Procedure Code, 1974, the Sessions Judge, Chennai Division makes the following arrangements for attending Urgent Criminal Work during Summer Recess, 2011 (01-05-2011 to 29-05-2011).

2. Thiru S. Rajagopalan, B.Sc., B.L., II Additional Judge, City Civil Court, Chennai will be incharge of Criminal Work during Summer Recess from 01-05-2011 to 29-05-2011.

3. The Vacation Sessions Judge will hold Courts on Wednesdays in every week during the vacation for the disposal of Urgent Criminal Matters.

#### PROCEDURE FOR THE RECEIPT AND DISPOSAL OF URGENT CRIMINAL MATTERS DURING SUMMER RECESS, 2011.

5. All urgent applications, Criminal Appeals, etc., shall be received only on Tuesdays upto 2.00 P.M. and the matters will be placed for orders before the Vacation Sessions Judge only on Wednesdays during vacation at 10.30 A.M. Applications and other matters shall not be presented at the residence of the Vacation Sessions Judge.

6. In all Bail Applications, including the applications for Anticipatory Bail, Notice shall be given to the City Public Prosecutor before filing the papers in Court and necessary endorsements shall be obtained from the City Public Prosecutor.

7. Clear and authenticated typed copies of the Judgements should be filed whenever certified copies are not easily decipherable.

8. In all cases wherein notices are to be issued sufficient number of copies of memorandum of grounds, petitions and affidavits shall be filed for service on the City Public Prosecutor as well as the Respondents concerned.
