(i) against the entry "AG-21, AGRICULTURAL (806 to 811)" the expression "807, 808 (except 807/1, 808/1)", shall be substituted.

(ii) against the entry "INDUSTRIAL", for the expression "Nil" the expression "807/1, 808/1" shall be added.
