Whereas in exercise of the powers conferred by clause (1) of Article 258 of the Constitution of India, the President has in the Ministry of Food, Agriculture, Community Development and Co-operation (Department of Agriculture) Notification No. 4(1)/65, General II, dated on the 23rd April 1966, entrusted to the Government of Tamil Nadu with their consent, the functions of the Central Government under the Land Acquisition Act, 1894 (Central Act 1 of 1894), in relation to acquisition of lands for the purpose of the Union in the State.

And, whereas, it has already been decided that the compensation should be paid from the public revenue.
