**Disqualification of certain Person as President, Vandalai  
Gudalur Village Panchayat, Pullampadi Panchayat Union,  
Tiruchirappalli District under the Tamil Nadu Panchayats  
Act.**

Raj (P.R.IV), 27th December 2010.]

No. II(2)/RDPR/44/2011.—Whereas, the opinion of the Tamil Nadu State Election Commission has been sought for, regarding the disqualification of Tmt. Ananthanayaki Murugavel, President, Vandalai Gudalur Village Panchayat, Pullampadi Panchayat Union, Tiruchirappalli District as required under sub-section (2) of Section 41 of the Tamil Nadu Panchayats Act, 1994 (Tamil Nadu Act 21 of 1994) as she is having interest in a subsisting contract work of construction of overhead tank under Member of Parliament Local Area Development Scheme to Vandalai Gudalur Village by awarding the said work in favour of her husband.

And, whereas, the Tamil Nadu State Election Commission, based on the records furnished by the Government has come to the conclusion that Tmt. Ananthanayaki Murugavel,

President, Vandalai Gudalur Village Panchayat has failed in her public duties and allowed her family to get benefit therefor. The said Commission is accordingly of the opinion that the said President, Vandalai Gudalur Village Panchayat, Pullampadi Panchayat Union, Tiruchirappalli District is disqualified to continue as President of the said Vandalai Gudalur Village Panchayat, under clause (c) of sub-section 3 of Section 38 of the said Act;

Now, therefore, under sub-section (1) of Section 41 of the Tamil Nadu Panchayats Act, 1994 (Tamil Nadu Act 21 of 1994), the Governor of Tamil Nadu hereby decides that Tmt. Ananthanayaki Murugavel, President, Vandalai Gudalur Village Panchayat, Pullampadi Panchayat Union, Tiruchirappalli District has become disqualified from holding the office of the President of the said Vandalai Gudalur Village Panchayat, under clause (c) of sub-section (3) of Section 38 of the said Act as she has failed in her public duties by having acquired interest in a subsisting contract work of construction of overhead tank to Vandalai Gudalur Village awarded in favour of her husband.
