No. II(2)/HWMP/415/2011.—The Governor of Tamil Nadu having satisfied that the lands specified in the Schedule below have to be acquired for Highways purpose to wit for the construction of Road Over Bridge in lieu of level crossing No.248 situated between Srirangam and Trichy Town Railway Stations and it having already been decided that the entire amount of compensation to be awarded for the lands is to be paid out of the funds controlled and managed by Divisional Engineer (Highways), Tiruchirappalli. The following Notice is issued under sub-section(1) of Section 15 of the Tamil Nadu Highways Act, 2001 (Tamil Nadu Act 34 of 2002).
