**Declaration of Tirumakottai Gas Turbine Power Station of Tamil Nadu Electricity Board, situated at Tirumakottai-I Village, Mannargudi Taluk, Tiruvarur District as a "Prohibited place" under the Act.**

And Whereas in pursuance of clause (1) of Article 258 of the Constitution of India, the Government of India, Ministry of Home Affairs, have in their Notification No. S.O. 1285, dated the 4th May 1963, published in the Gazette of India, dated the 11th May 1963, entrusted to the Government of Tamil Nadu, the functions of the Central Government in relation to any matter specified in sub-clauses (c) and (d) of clause (8) of Section 2 of the Official Secrets Act, 1923 (Central Act XIX of 1923);

**Declaration of the Valuthur Gas Turbine Power Station, Phase-I and Phase-II of Tamil Nadu Electricity Board, Valanthuravai Village, Ramanathapuram District as a "Prohibited Place" under the Act.**

No. II(1)/PUSC/20/2011.—Whereas in the opinion of the Government of Tamil Nadu, it is necessary to declare the Valuthur Gas Turbine Power Station, Phase-I and Phase-II of Tamil Nadu Electricity Board situated in the Survey Nos. 256, 259, 260, 269, 270 and 271 to the extent of 17.68.5 hectares at Valanthuravai Village, Ramanathapuram District as specified in the Schedule below, to be a "Prohibited Place" under sub-clause (d) of clause (8) of Section 2 of the Official Secrets Act, 1923 (Central Act XIX of 1923), on the ground that information with respect thereto, or the destruction or obstruction thereof, or interference therewith, would be useful to an enemy;
