Ramalakshmi, 1st Ward Member, Themankulam Village Panchayat, Alwarthirunagiri Panchayat Union, Thoothukkudi District has become disqualified under clause (i) of sub-section (3) of Section 38 of the Tamil Nadu Panchayats Act, 1994 (Tamil Nadu Act 21 of 1994), as she has absented herself from three consecutive meetings of the said Village Panchayat; .

And whereas, the opinion of the Tamil Nadu State Election Commission has been sought for regarding the disqualification of the said member of the said Panchayat, as required under sub-section(2) of Section 41 of the said Act;

And whereas, the Tamil Nadu State Election Commission, after conducting an enquiry, has stated that on verification of the relevant records of Themankulam Village Panchayat,

it has been confirmed that, Thirumathi K.Ramalakshmi, 1st Ward Member of the said Village Panchayat, has not attended more than three consecutive meetings of the said Village Panchayat held on or after 29th April, 2008 and she has received the show cause notices issued to her in this regard, which shows that she is not willing to continue as Ward Member in the said Village Panchayat and has also opined that the said Thirumathi K. Ramalakshmi, 1st Ward Member, Themankulam Village Panchayat, Alwarthirunagari Panchayat Union; Thoothukkudi District is disqualified to continue as member of the said Themankulam Village Panchayat, under clause (i) of sub-section (3) of Section 38 of the said Act;

Now therefore, under sub-section (1) of Section 41 of the Tamil Nadu Panchayats Act, 1994 (Tamil Nadu Act 21 of 1994), the Governor of Tamil Nadu hereby decides that Thirumathi K.Ramalakshmi, 1st Ward Member, Themankulam Village Panchayat, Alwarthirunagari Panchayat Union, Thoothukkudi District, has become disqualified from holding the office of 1st Ward Member of the said Themankulam Village Panchayat, under clause (i) of sub-section (3) of Section 38 of the said Act, as she has absented herself from three consecutive meetings of the said Village Panchayat held on or after 29th April, 2008.
