Amendments to the Tamil Nadu State Judicial Service (Cadre and Recruitment) Rules, 2007

No. SRO B-1/2012.—In exercise of the powers conferred by the Articles 233, 233-A, 234 and 235 and the proviso to Article 309 of the Constitution of the India, the Governor of Tamil Nadu, in consultation with the High Court, Madras, hereby makes the following amendments to the Tamil Nadu State Judicial Service (Cadre and Recruitment) Rules, 2007 as subsequently amended:—

AMENDMENTS

In the said Rules in the Schedule to rule 5, in column (4), against the entry "Civil Judges" in column (2),-

(1) in clause (2), for the expression "Age: Must have attained the age of 25 years and must not have attained the age of 38 years in the case of Scheduled Caste/Scheduled Tribes and 35 years in the case of others as on 1st July of the year in which the selection for appointment is made", the expression "Age: Must have attained the age of 25 years and must not have attained the age of 35 years in the case of General Category and 40 years in the case of Reserved Categories, as on the 1st July of the year in which the vacancies in the posts are notified" shall be substituted;

- (2) clause (4) shall be omitted;
- (3) for the explanation, the following explanation shall be substituted, namely:-

Explanation,—Rules 12(d) (ii), 52 and 53 of the General Rules for the Tamil Nadu State and Subordinate Services shall not apply for this recruitment.

Amendments to the ad hoc rules relating to the temporary post of Technical Officer in the Commissionerate for the Differently Abled

No. SRO B-2/2012.—In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India, the Governor of Tamil Nadu hereby makes the following amendments to the rules published with the Social Welfare and Nutritious Meal Programme Department Notification SRO B-67/2003, at pages 83-84 of Part III—Section 1(b) of the *Tamil Nadu Government Gazette*, dated the 25th June 2003:—

AMENDMENTS

In the said Rules:-

(1) for rule 3, the following rule shall be substituted, namely,-

"3. Appointment:---

Appointment to the post shall be made as follows:-

- (i) By direct recruitment; or
- (ii) By recruitment by transfer from the holders of the following posts:-

(a) Placement Officer in the Tamil Nadu Educational Subordinate Service; or

(b) Orthotic-cum-Prosthetic Engineer or District Differently Abled Welfare Officer in the Tamil Nadu General Subordinate Service.";

(2) in rule 4, in the TABLE, for the entry "2 Recruitment by Transfer from the holders of the post of Placement Officer" in column (1) and the corresponding entries in column (2) thereof, the following entries shall, respectively, be substituted, namely:—

"2. Recruitment by transfer:---

- (a) From the holders of the post of Placement Officer.
 (i) Diploma in Mechanical, Electrical, Electronics or Prosthetics and Orthotics Engineering awarded by the Directorate of Technical Education, Tamil Nadu; and
 - (ii) Experience for a period of not less than five years in the field of rehabilitaion for the Differently Abled.
- (b) From the holders of the post of Orthotic-cum-Prosthetic Engineer.
- (i) Diploma in Orthotic-cum-Prosthetic Engineering awarded by the Directorate of Technical Education, Tamil Nadu; and
- (ii) Experience for a period not less than five years in the field of rehabilitation of Differently Abled.
- (c) From the holders of the post of District Differently Abled Welfare Officer.

Experience for a period of not less than five years in the field of rehabilitation for the Differently Abled.
