### PERSONNEL AND ADMINISTRATIVE REFORMS DEPARTMENT

#### Amendment to the Special Rules for the Tamil Nadu Basic Service.

[G.O. Ms. No. 21, Personnel and Administrative Reforms (F), 6th February 2012, கை 23, திருவள்ளூர் ஆண்டு-2043.]

No. SRO B-6 /2012.—In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India, the Governor of Tamil Nadu hereby makes the following amendment to the Special Rules for the Tamil Nadu Basic Service (Section 19 in Vol. III of the Tamil Nadu Services Manual, 1970):—

2. The amendment hereby made shall be deemed to have come into force on the 29th November 2010.

#### AMENDMENT

In the said Rules, in rule 3, in sub-rule (a), after the third proviso, the following proviso shall be added, namely:—

“Provided also that ten per cent of the vacancies that arise in the post of Office Assistant in the Revenue Department shall be filled up by recruitment by transfer from among the persons holding the posts of Village Assistants, who have completed ten years of service as Village Assistant and who are possessing the requisite educational qualification for appointment to the post of Office Assistant.”

#### Amendments to the Tamil Nadu Civil Services (Discipline and Appeal) Rules.

[G.O. Ms. No. 29, Personnel and Administrative Reforms (N), 23rd February 2012, மாசி 11, திருவள்ளூர் ஆண்டு-2043.]

No. SRO B-7/2012.—In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India, the Governor of Tamil Nadu hereby makes the following amendments to the Tamil Nadu Civil Services (Discipline and Appeal) Rules (in Volume I of the Tamil Nadu Services Manual, 1987).

2. The amendments hereby made shall come into force on the 23rd February of 2012.

#### AMENDMENTS

In the said Rules, in rule 17, in sub-rule (e), in clause (1),—

- (1) in sub-clause (i), for the expression “an enquiry into grave charges”, the expression “a disciplinary proceedings” shall be substituted;
- (2) for sub-clause (ii), the following sub-clause shall be substituted, namely:—  
“(ii) a case against him in respect of any criminal offence is under investigation, inquiry or trial”.
