The Government in consultation with the Hon'ble High Court, Madras, appointed 17 District Judges (Entry Level) among others Thiru S. Pandiarajan, Advocate, Tirunelveli at Sl. No. 4 in the Government Order first read above. Now it has been brought to the notice of the Government that on the date of application i.e., on 6th July 2010, Criminal Case No.2/2007 on the file of Pavorchathiram Police Station, Tirunelveli District, was pending against Thiru S. Pandiarajan as per the notification calling for application to the post of District Judge (Entry Level), Thiru S. Pandiarajan submitted his application dated 6th July 2010, declaring 'NIL' against column No.10 which requires a candidate to declare 'whether the applicant is involved in any litigation Civil/Criminal'.

2. The Hon'ble High Court called for a report from the Principal Judge, Tirunelveli. The Government informed the Hon'ble High Court, Madras vide D.O. Letter dated 18th February 2011 that Cr.No.2/2007 has been treated as "Mistake of fact" and the same was approved by the Judicial Magistrate, Tenkasi on 11th February 2011 by assigning Rc. No.9/2011. In the light of the report of the Principal District Judge, Tirunelveli, and the remarks of the Government D.O. Letter dated 18th February 2011, the Hon'ble High Court considered the representation of Thiru S. Pandiarajan and found that Thiru S. Pandiarajan has not only suppressed the pendency of the Criminal Case against him, but also made a false declaration in his application, thereby he rendered

himself ineligible/disqualified to apply for the post of District Judges (Entry Level) and also for the consequential selection. The Hon'ble High Court, Madras has withdrawn the recommendation made to Government to appoint Thiru S. Pandiarajan as District Judge (Entry Level).

3. The Government forwarded the further representation of Thiru S. Pandiarajan, dated 25th March 2011 to the Hon'ble High Court, Madras. The Hon'ble High Court, Madras considered his representation and rejected the same, finding no merit in it.

4. Therefore the Government direct that name of Thiru S. Pandiarajan, Advocate, Tirunelveli alone appearing against Sl.No.4 in the appointment order made in para 1 of the Government Order first read above shall be deleted with immediate effect and his appointment as District Judge (Entry Level) are hereby cancelled.

In Continuation of G.O. second read above, under rule 5 of the Tamil Nadu State Judicial Service (Cadre and Recruitment) Rules, 2007, the Government in consultation with the Hon'ble High Court, Madras, Chennai hereby appoint Thiru P. Sivakumar, son of Thiru M. Prakasam, Salem as District Judges (Entry Level).

2. The above said District Judge (Entry Level), will draw a pay of Rs.51,550/- in the scale of pay of Rs.51,550-1230-58930-1380-63070 and other usual allowances and he will be on probation for a total period of 2 years from the date of joining duty within a continuous period of three years. The above said candidate is requested to furnish Physical fitness certificate direct to the Registrar General, High Court of Madras under intimation to Government.

3. During the period of probation, the above District Judge will undergo:—

(i) Training as Civil Judge (Junior Division) for a period of not less than six months;

(ii) Training as Civil Judge (Senior Division) for a period of not less than six months; and

(iii) Training in Forensic Science for a period of not less than two months;

4. The above District Judge (Entry Level) should also pass the Account Test for Executive Officers within the period of probation. Only after satisfactory completion of the training, the above District Judge will be posted to act as District Judge (Entry Level).

5. The Posting orders for training as Civil Judge (Junior Division), Civil Judge (Senior Division), etc. and joining instructions will be issued by the Hon'ble Madras High Court. The above District Judge (Entry Level) is informed that other terms and conditions specified in Tamil Nadu State Judicial Service (Cadre and Recruitment) Rules, 2007, shall apply to him.
