## LABOUR AND EMPLOYMENT DEPARTMENT

**Extension of Employees State Insurance scheme to certain new Sectors of establishments in all the implemented areas under State Insurance Act.**

[G.O.Ms.No. 45, Labour and Employment (K1),  
27th March 2012.]

No. II(2)/LE/235/2012.—In exercise of the powers conferred by sub-section (5) of Section 1 of the Employees' State Insurance Act, 1948 (Central Act XXXIV of 1948), the Governor of Tamil Nadu, in consultation with the Employees' State Insurance Corporation and with the approval of the central Government, after complying with the statutory requirement of giving six months notice of the intention of this Government *vide* Labour and Employment Department Notification No. II(2)/LE/145/2010, Published at page 120 of Part II-Section 2 of the *Tamil Nadu Government Gazette*, dated the 10th March 2010, hereby extends the provisions of the said Act to the class of establishments specified in column (1) of the Schedule below, situated in the areas specified in the corresponding entries in

column (2) thereof, with effect from the date of publication of this Notification in the *Tamil Nadu Government Gazette*.

## THE SCHEDULE.
