NOTIFICATIONS BY GOVERNMENT

HEALTH AND FAMILY WELFARE DEPARTMENT

Ad hoc rules relating to the Temporary Post of Health Education Extension Officer in the Regional Family Planning Training Centres of the Tamil Nadu Public Health Service.

(G.O. Ms. No. 825, Health and Family Planning, 29th March 1973.)

No. SRO B-17/2012.—In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India, the Governor of Tamil Nadu hereby makes the following Rules:—

The rules hereby made shall be deemed to have come into force on the 29th October 1965.

RULES

The General and the Special Rules applicable to the holders of the permanent posts in the Tamil Nadu Public Health Service shall apply to the holders of the temporary posts of Health Education Extension Officers in the Regional Family Planning Training Centres at Salem and Egmore, subject to the modifications specified in the following rules:—

2. *Constitution.*—The post shall constitute a distinct category in the said service.
3. *Appointment.*—Appointment to the post shall be made as follows:—
 - (i) Direct recruitment; or
 - (ii) by recruitment by transfer from any category in the Tamil Nadu Public Health Subordinate Service or from the Tamil Nadu Medical Subordinate Service or from any other Service.
4. *Qualifications.*—(a) *Age.*—No person shall be eligible for appointment to the post by direct recruitment unless he has completed or will complete 25 years of age but has not completed or will not complete 35 years of age on the 1st day of July of the year in which selection for appointment is made.

(b) *Other Qualifications.*—No person shall be eligible for appointment to the post unless he possesses the following qualifications namely:—

 2. Experience in teaching and or social work including Family Planning for a period of not less than 5 years.

Provided that preference shall be given to those with a diploma in Health Education.
5. *Probation.*—Every Person appointed to the post shall from the date on which he joins duty, be on probation for a total period of two years on duty within a continuous period of three years.
6. *Pay.*—There shall be pay to the holders of the post a monthly pay calculated in the scale of Rs. 225-10-275-15-350 Provided that as and from 2nd October 1970 a monthly pay shall be calculated in the scale of Rs. 400-15-475-20-575-25-650.

Ad hoc rules relating to the Temporary Post of Health Education Extension Officer (Non-Gazetted) in the Regional Family Planning Training Centres for the Tamil Nadu Public Health Subordinate Service.

[G.O. Ms. No. 826, Health and Family Planning, 29th March 1973.]

No. SRO B-18/2012.—In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India, the Governor of Tamil Nadu hereby makes the following Rules:—

The rules hereby made shall be deemed to have come into force on the 29th October 1965.

RULES

The General and the Special Rules applicable to the holders of permanent posts in the Tamil Nadu Public Health Subordinate Service shall apply to the holders of the temporary post of Health Education Extension Officer

(non-gazetted) in the Regional Family Planning Training Centre at Egmore, subject to the modification specified in the following rules:—

2. *Constitution.*—The post shall constitute a distinct category in the said service.

3. *Appointment.*—Appointment to the post shall be made as follows:—

(i) by direct recruitment; or

(ii) by transfer from any other category in the Tamil Nadu Public Health Subordinate Service; or

(iii) by recruitment by transfer from the Tamil Nadu Medical Subordinate Service or from any other Service.

4. *Appointing Authority.*—The Appointing Authority for the post shall be the Director of Health Services and Family Planning, Madras.

5. *Qualifications.*—(a) *Age.*—No person shall be eligible for appointment to the post by direct recruitment unless he has completed or will complete 25 years of age but has not completed or will not complete 35 years of age on the 1st day of July of the year in which selection for appointment is made.

(b) *Other Qualifications.*—No person shall be eligible for appointment to the post unless he possesses the following qualification:—

1. Second Class Masters Degree in Social Science, Social Works or Education.

2. Experience in teaching and or Social Work including Family Planning for a period of not less than 5 years. Provided that preference shall be given to those with a Diploma in Health Education.

6. *Probation.*—Every Person appointed to the post shall from the date on which he joins duty, be on probation for a total period of two years on duty within a continuous period of three years.

7. *Pay.*—There shall be pay to the holders of the post a monthly pay calculated in the scale of Rs. 225-10-275-15-350.

Provided that as and from 2nd October 1970 a monthly pay shall be calculated in the scale of Rs. 400-15-475-20-575-25-650.

Amendments to the Special Rules for the Tamil Nadu School Educational Service

[G.O. Ms. No. 127, School Education (A1), 25th May 2012, வைகாசி 12, திருவள்ளூர் ஆண்டு-2043.]

No. SRO B-19/2012.—In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India, the Governor of Tamil Nadu hereby makes the following amendments to the Special Rules for the Tamil Nadu School Educational Service (Section 8-A in Volume-II of the Tamil Nadu Services Manual, 1969).

2. The amendments hereby made shall come into force on 25th May 2012.

AMENDMENTS

In the said Special Rules,

(1) in rule 2, in sub-rule (a), under class V, in column (2), against the entry "Headmasters and Headmistresses including Headmasters and Headmistresses in the Model High Schools attached to Training Colleges in the Collegiate Education Department" in column (1) thereof;

(i) after the expression "Physical Directors in the Tamil Nadu Educational Subordinate Service", the expression "Assistant Elementary Educational Officers in the Tamil Nadu Elementary Educational Subordinate Service" shall be added;

(ii) after the proviso, the following proviso shall be added, namely:—

“Provided further that three percent of the vacancies shall be filled up from among the holders of the post of Assistant Elementary Educational Officer in Category-I of Class-I of the Tamil Nadu Elementary Educational Subordinate Service.”

(2) in rule 2-B, for the expression “and Physical Directors”, the expression “Physical Directors and Assistant Elementary Education Officers” shall be substituted.

(3) in the Annexure, in column (3) against the entry “Recruitment by transfer” in column (2) and the entry “Headmasters and Headmistress including Headmasters and Headmistress in Model High Schools attached to Training Colleges in the Collegiate Education Department” in column (1) thereof, in item (iii), after the proviso, the following proviso shall be added, namely:—

“Provided further that for appointment from the post of Assistant Elementary Educational Officer, must have served for a period of not less than five years in that post”.
