The powers may be withdrawn as and when they complete their training to the satisfaction of the Chief Judicial Magistrates concerned and confers upon them the ordinary powers conferrable under this Code on a Magistrate to try such cases which were triable and dealt with by an erstwhile Judicial Second Class Magistrate.
