DRAFT NOTIFICATION

In exercise of the powers conferred by clause (b) of sub-section (1) of Section 3 and sub-section (2) of Section 5 read with clause (c) of sub-section (2) of Section 3 of the Minimum Wages Act, 1948 (Central Act XI of 1948) and in supersession of the Labour and Employment Department Notification No.II(2)/LE/240/2007, published at page 193 of Part II—Section 2 of the *Tamil Nadu Government Gazette*, dated the 9th May 2007, the Governor of Tamil Nadu hereby revises the guaranteed time rate of wages payable to beedi rollers in the employment in Tobacco (including beedi making) manufactory as follows:—

(i) Where the employer fails to supply sufficient quantum of good raw materials (including tobacco leaves) to roll one thousand beedies per day, the employees (beedi-rollers) shall be entitled to get Rs. 24.80 (Rupees twenty four and paise eighty only) as guaranteed time rate of wages.

(ii) The payment of guaranteed time rate of wages as aforesaid shall be subject to the following conditions, namely:—

(a) that the employee shall not be entitled for payment of guaranteed time rate of wages, if he does not fully make use of the raw materials supplied by the employer, even if it is inadequate to roll one thousand beedies;

(b) that the employee shall not be entitled to get the guaranteed time rate of wages, if he earns less than the amount of guaranteed time rate of wages on any day, on account of his unwillingness to work for any reason whatsoever;

(c) that the employee shall not entitled to get the guaranteed time rate of wages, if the failure of the employer to supply raw materials is due to tempest, fire, rain, catastrophe, epidemics, civil commotion or any other similar cause which is beyond the control of the employer; and

(d) that the employee who works for more than one employer shall not be entitled to get the guaranteed time rate of wages from anyone of those employers.
