Order: No. 543, Public (Special-B) 5th July 2012.

In the reference first read above, orders were issued regarding the inter-se-seniority of Ministers and the subjects allocated to them.

- 2. In the reference second read above, the Principal Secretary to Government, Environment and Forests Department has stated that in the year 1990 itself in G.O. Ms. No. 221, Environment and Forests Department, dated 3rd April 1990, the Department 'Cinchona' was wound up and the staff were merged with Forests Department and there is no separate department in the name of 'Cinchona' at present. The Principal Secretary to Government, Environment and Forests Department has therefore requested to delete the subject matter 'Cinchona' from the Hon'ble Minister (Forests) by making an amendment.
- 3. The Government have examined the above request in detail. Accordingly, the Government direct that, the subject 'Cinchona' be deleted from the subjects allocated to Minister (Forests) and henceforth Thiru K.T. Pachamal, Minister for Forests will handle the subject "Forests" alone.
