In exercise of the powers conferred under Section 33(2) of Town and Country Planning Act 1971. The Commissioner of Town and Country Planning, Chennai here by confirms the following variation to the approved Lakshathoppu Area Detailed Development Plan of Pattukottai Local Planning Area, approved by Director of Town and Country Planning Proceeding in Roc. No. 12950/90 DP3 dated: 4-4-90 and the fact of this approval in Form No.12 published in *Tamil Nadu Government Gazette* No. Part VI—Section 1, Page No. 737, dated 5-9-1990, publication No. VI(1)/1118/90 and the said draft Notification was published in *Tamil Nadu Government Gazette* No. 24, Part VI—Section 1 Page Nos. 255 & 256, dated: 20-6-2007 Publication No.VI(1)/339/2007.

Since no objections and suggestions have been received on this draft notification with in the stipulated time, the same are hereby confirmed and ordered as below:

## CONFIRMATION OF VARIATION

1. The entire Lakshathoppu Area Detailed Development Plan of Pattukkottai Local Planning Area. Approved by Director of Town and Country Planning Proceedings Roc.No.12950/90 DP3 dated: 4-4-90 was varied by Lakshathoppu Area Detailed Development Plan of Pattukkottai Local Planning Area.
