Amendment to Tamil Nadu Industrial Employment (Standing Orders) Rules.

[G.O. (2D) No.73, Labour and Employment (G1), 25th November 2010.]

No. SRO A-27/2012.—The following draft of an amendment to the Tamil Nadu Industrial Employment (Standing Orders) Rules, 1947, which it is proposed to make in exercise of the powers conferred by Section 15 of the Industrial Employment (Standing Orders) Act, 1946 (Central Act XX of 1946), is hereby published for information of all persons likely to be affected thereby as required by sub-sections (1) of Section 15 of the said Act.

2. Notice is hereby given that the draft amendment will be taken into consideration on or after the expiry of two months from the date of publication of this Notification in the *Tamil Nadu Government Gazette* and that any objection or suggestion, which may be received from any person with respect thereto before the expiry of the period aforesaid will be considered by the Government of Tamil Nadu. Objection or suggestion, if any, should be addressed to the Principal Secretary to Government, Labour and Employment Department, Government of Tamil Nadu, Chennai-600 009 through the Commissioner of Labour, Chennai-600 006.

"(1) Five copies of the draft standing orders in English and in Tamil, which an employer proposes to adopt for his industrial establishment shall be sent by him, by registered post, to the Certifying Officer along with the required number of spare copies to the trade union in the establishment".

No. SRO A-28/2012.—In exercise of the powers conferred by Section 112 read with Section 7-AA of the Factories Act, 1948 (Central Act LXIII of 1948), the Governor of Tamil Nadu hereby makes the following amendments to the Tamil Nadu Factories Rules, 1950, the draft of the same having been previously published as required by Section 115 of the said Act.

AMENDMENTS

In the said Rules,-

(i) under rule 95, in Schedule XXIV, after paragraph 12, the following paragraph shall be inserted, namely:-

"12-A Personal Accident Insurance.—The occupier of every factory wherein the manufacture of match or fire work is carried on shall prepare a report containing the details of the insurance coverage in respect of the workers employed, in such factory in Form No.41 and send it to the Chief Inspector once in six months through the Deputy Chief Inspector of Factories having jurisdiction over the area where the factory is situated.";
