Declaration of “Industries Manufacturing Steam Generation Equipments like High Pressure Boilers, Valves and Fittings, Pressure Vessels and Package Boilers” as public utility service under Industrial Disputes Act.

[G.O. (Rt) No. 18, Labour and Employment (D2),
12th January 2012.]

No. II(2)/LE/100/2012.—Whereas, the Governor of Tamil Nadu is satisfied that public interest requires that the “Industries manufacturing steam generation equipments like high pressure boilers, valves and fittings, pressure vessels and package boilers” should be declared to be a public utility service for the purposes of the Industrial Disputes Act, 1947 (Central Act XIV of 1947);

Now, Therefore, in exercise of the powers conferred by sub-clause (vi) of clause (n) of Section 2 of the said Act, the Governor of Tamil Nadu hereby declares that the “Industries manufacturing steam generation equipments like high pressure boilers, valves and fitting, pressure vessels and package boilers” to be a public utility service for the purposes of the said Act, for a period of six months with effect on and from the date of publication of this Notification in the *Tamil Nadu Government Gazette*.

under the Disaster Management Act.**

[G.O. Ms. No. 33, Revenue (DMI (2), 24th January 2012.]

No. II(2)/REV/104/2012.—Under sub-sections (1) and (2) of Section 25 of the Disaster Management Act, 2005 (Central Act 53 of 2005), the Governor of Tamil Nadu hereby establishes the District Disaster Management Authority, consisting of the following members, namely:—

1. District Collector- Chairperson, *Ex-Officio*;
2. District Panchayat Chairman – Co-Chairperson, *ex-officio*;
3. Superintendent of Police, *ex-officio*;
4. District Revenue Officer who shall function as the Chief Executive Officer of the District Authority, *ex-officio*;
5. Joint Director, Health Services, *ex-officio*;
6. Personal Assistant (General) to Collector and Additional Collector (Development)/Project Officer (District Rural Development Authority).
