[G.O. Ms. No. 30, Labour and Employment (M-2), 22nd February 2012, Maasi 10, Thiruvalluvar Aandu-2043.]

No. SRO A-7/2012.—The following draft of amendments to the Tamil Nadu Factories Rules, 1950 which it is proposed to make in exercise of the powers conferred by Section 112 read with section 7-AA of the Factories Act, 1948 (Central Act LXIII of 1948) is hereby published for the information of all persons likely to be affected thereby, as required by Section 115 of the said Act.

2. Notice is hereby given that the said draft amendments will be taken into consideration of or after the expiry of forty five days from the date of publication of this Notification in the *Tamil Nadu Government Gazette* and any objection or suggestion, which may be received from any person with respect thereto before the expiry of the aforesaid period will be considered by the Government of Tamil Nadu. Objection or suggestion, if any, should be addressed to the Principal Secretary to Government, Labour and Employment Department, Secretariat, Chennai-600 009 through the Chief Inspector of Factories, Chennai-600 005 in duplicate.

#### DRAFT AMENDMENTS.

In the said Rules,-

- (i) under rule 95, in Schedule XXIV, after paragraph 12, the following Paragraph shall be inserted, namely,—
- "12-A. Personal Accident Insurance.—The occupier of every factory wherein the manufacture of match or fire work is carried on shall prepare a report containing the details of the insurance coverage in respect of the workers employed in such factory in Form No. 41 and send it to the Chief inspector once in six months through the Deputy Chief Inspector of Factories having jurisdiction over the area where the factory is situated.";
  - (2) after Form No. 40, the following Form shall be added, namely:-
