It is hereby notified that the election to [i] THE SYNDICATE and [ii] THE ACADEMIC COUNCIL will be held under Section 18[a]-Other Members sub-section [1] and Section 23[a] - Other Members, sub-section [1] of the Madras University Act, 1923 respectively.
