

Form the Registrar General, High Court, Madras, D.O.Letter No. 47/2011-Con.B2, dated 21st December 2011.

#### Order: No. 31, Public (Special A), 22nd February 2012.

The Government have considered the recommendation of the High Court, Madras to depute Thiru C.S. Murugan, District Judge of the Tamil Nadu State Judicial Service functioning as Principal District Judge, Dindigul to the Puducherry Judicial Service for being posted as Chief Judge, Puducherry, in the place of Thiru T. Ramasamy, who has been ordered to be repatriated to his parent Department *viz.*, Tamil Nadu State Judicial Service.

2. The Government accordingly direct that Thiru C.S. Murugan, District Judge of Tamil Nadu State Judicial Service functioning as Principal District Judge, Dindigul be deputed to the Puducherry Judicial Service for being posted as Chief Judge, Puducherry in the place of Thiru T. Ramasamy, with effect from the date of assuming office as such.
