Amendment to the Removal of (Licensing Requirements, Stock Limits and Movement Restrictions) on Specified Foodstuffs Order, 2002.

No. II(1)/CFCP/8/2013.—The following order of the Gazette of India Ministry of Consumer Affairs , Food and Public Distribution (Department of Consumer Affairs), New Delhi, the 20th December 2012 is republished:—

- **S.O.2968(E).**—In exercise of the powers conferred by Section 3 of the Essential Commodities Act, 1955 (10 of 1955) the Central Government hereby makes the following Order further to amend the Removal of (Licensing Requirements, Stock Limits and Movement Restrictions) on Specified Foodstuffs Order, 2002, namely:—
- 1. (1) This order may be called the Removal of (Licensing requirements, Stock Limits and Movement Restrictions) on Specified Foodstuffs (Second Amendment) Order, 2012.
 - 2. It shall come into force after fifteen days of the publication of this Order in the Official Gazette.
 - 3. It extends to the whole of India.

In the Removal of (Licensing Requirements, Stock limits and Movement Restrictions) on Specified Foodstuffs Order, 2002, in clause 7, in sub-clause (1), for item (iii), the following items shall be substituted, namely:—

"(iii) paddy and rice for a period upto and inclusive of 30th day of November, 2013 from the date on which this order comes into force".

INTRODUCTION OF ac 25 kV TRACTION

"WARNING TO ROAD USERS"

No. II(1)/TDREI/10/2013.—It is notified for information of the Public that in connection with introduction of 25 kV ac electric traction over the section of

- (i) New BG division line from km/loc.B-96/22 (ch. 96/602.90) to km/loc.B-98/28 (ch. 98/819.30) at Acharapakkam Station and
- (ii) Newly laid BG UP line between Melmaruvathur (excl.) and Thozhuppedu (incl.) stations from km/loc.96/17 (ch.96/431.90) to km./loc.104/19A (ch.104/565.75) in Chennai Division of Southern Railway, the height gauges have been erected at all the level crossings with clear height of 4.67 m above road level with a view to prevent loads of excessive height from coming into contact or dangerous proximity to live traction wires.

Public are hereby notified to observe the height specified above for the purpose of loading vehicles and to see that the loads carried in road vehicles do not infringe the height gauges under any circumstances.

The dangers of a Load of Excessive Height are as follows.

- (i) Danger to the height gauge and consequent obstruction to the road as well as the Railway line.
- (ii) Danger to the materials or equipment carried or for the vehicle itself.
- (iii) Danger of fire and risk of life due to contact with or dangerous proximity to the conductors.
