No.II/HWMP/283/2013.—Whereas, in exercise of the Powers conferred by clause (1) of Article 258 of the constitution of India, the President of India has in the Ministry of Food, Agriculture Community Development and Co-operation (Department of Agriculture) Notification No. 4 (1) 665/General II dated 23-04-1966 entrusted to Government of Tamil Nadu with their consent the functions of the central Government under the Land Acquisition Act 1894 (Central Act 1 of 1894) in relation to acquisition of land for the purposes of the union in this state.

And whereas the Government of Tamil Nadu having been satisfied that the Lands specified in the schedule below have to be acquired for a public purpose and it having already been decided that the entire amount of compensation to be awarded for the Lands to be paid out of Public Revenue the following declaration is issued Under Section 6 of the Land Acquisition Act 1894 (Central Act 1 of 1894).

DECLARATION

Under Section 6 of the Land Acquisition Act, 1894 (Central Act 1 of 1894), the Governor of Tamil Nadu hereby declares that the Lands specified in the schedule below and measuring 0.28.10 Ha be the same a little more or less are needed for a public purpose to wit for construction of two new Railway lines from Athipattu Railway Station to the Iron ore / Coal stack yards of Ennore Port Limited through Railway Department.

I am to invite attention to the references cited.

2. In the Government order first cited, Government has constituted the State Level Steering Committee under the Chairmanship of Chief Secretary, District Level Monitoring Committee under the Chairmanship of District Collectors and Co-ordination Committee for Corporation of Chennai under the Chairmanship of Commissioner, Chennai Corporation for the smooth functioning of 6th Economic Census for the period of 30 months from October 2011 to March 2014.

3. In the reference second read above, the Deputy Director General, Ministry of Statistics and Programme Implementation, Government of India, has stated that the Sixth Economic Census is proposed to be conducted in Tamil Nadu during April-June 2013. Further as per the orders issued in the Government Order first cited, the Assistant Director of Statistics will be the Convenor of the District Monitoring Committee and the Co-ordination Committee for Corporation of Chennai. In this connection Government in the Government Order third cited has restructured the department and accordingly, the District Statistical units are headed by the Deputy Director of Statistics.

4. The Principal Secretary and Director, Department of Economics and Statistics in his letter third refereed above has proposed the Government to issue necessary revised orders to conduct the Sixth Economic Census in any month between April to June 2013 instead of Jan-June 2012 for the period of 30 months from February 2013 to July 2015. As per the restructuring staff pattern of Department of Economics and Statistics, the Assistant Director of Statistics in the District has been upgraded as Deputy Director. Therefore, the designation may be changed as Deputy Director instead of Assistant Director of Statistics in the District Monitoring Committee has already been issued in the Government Order referred above.

5. I am therefore to state that in partial modification of the orders issued in the Government Order first cited, that the State Level Steering Committee, District Monitoring Committee and Co-ordination Committee for Corporation of Chennai formed in connection with the Sixth Economic Census would function for a period of 30 months between February 2013 to July 2015. The Deputy Director of statistics will be the Convenor of the District Monitoring Committee and the Co-ordination Committee for Chennai Corporation.
