HOME, PROHIBITION AND EXCISE DEPARTMENT

Amendments to the Tamil Nadu Liquor (Supply by Wholesale) Rules.

[G.O.Ms. No.11, Home, Prohibition and Excise (VIII), 26th March 2013.]

No. SRO A-5/2013.—In exercise of the Powers conferred by Sections 17-D and 54 of the Tamil Nadu Prohibition Act, 1937 (Tamil Nadu Act X of 1937), the Governor of Tamil Nadu hereby makes the following amendments to the Tamil Nadu Liquor (Supply by Wholesale) Rules, 1983:-

2. The amendment hereby made shall be deemed to have come into force with effect on and from the 1st April 2012.

In the said Rules in rule 15, sub-rule (3) in the tabulor column, in the third column, - (I) for the expression "74.30" against item (i) in the first column, the expression "77.60" shall be substituted; and

[G.O. Ms. No.14, Home, Prohibition and Excise (VIII), 29th March 2013.]

No. SROA-10/2013.—In exercise of the Powers conferred by Section 54 read with Section 17-C, 17-D, 17-E, 18-B, 18-B, 18-C, 20 and 21 of the Tamil Nadu prohibition Act, 1937 (Tamil Nadu Act X of 1937), the Governor of Tamil Nadu hereby makes the following amendments to the Tamil Nadu Liquor (Licence and Permit) Rules, 1981:-

2. The amendment hereby made shall be come into force on the 1st April 2013.

AMENDMENT

In the said Rules.-

(I) in rule 17, in sub rule (b), in clause XI-B, for the sentence beginning with the words "The application shall be accompanied" and ending with the words" for the grant of licence", the following sentence shall be substituted, namely:—

"The application shall be accompanied by the Treasury receipt in proof of the payment of annual privilege fee of Rs. 1,00,000/- (Rupees One Lakh only) licence fee of Rs. 1,000/- (Rupees One Thousand only) and application fee of Rs. 100/- (Rupees One hundred only) for the grant of licence.";

(2) in "Form F.A.I. 13", for the expression "(a) Application fee of Rs. 1,000/- (Rupees One thousand only)", "(b) Licence fee of Rs. 1,00,000/- (Rupees One lakh only)" and "(c) Privilege fee Rs.1,00,00,000/- (Rupees One Crore only)", the expressions "(a) Application fee of Rs.100/- (Rupees One hundred only)", "(b) Licence fee of Rs. 1,000/- (Rupees one thousand only)" and "(c) Privilege fee of Rs. 1,00,000/- (Rupees One lakh only)" shall, respectively, be substituted.

No. SROA-11/2013.—In exercise of the Powers conferred by Sections 17-C, 17-D, 21 and 22-D read with Section 54 of the Tamil Nadu Prohibition Act, 1937 (Tamil Nadu Act X of 1937), the Governor of Tamil Nadu hereby makes the following amendment to the Tamil Nadu Liquor Retail Vending (in Shops and Bars) Rules, 2003:-

AMENDMENTS

In "the Rules in rule 2, in clause (oo), for the expression "at the rate of 10%," the expression" at the rate of 0.05% shall be substituted.

[G.O. Ms. No. 19, Home, Prohibition and Excise (VI), 29th March 2013.]

No. SROA-12/2013.—In exercise of the Powers conferred by Sections 17-C, 17-D, 21 and 22-D, read with Section 54 of the Tamil Nadu Prohibition Act, 1937 (Tamil Nadu Act X of 1937), the Governor of Tamil Nadu hereby makes the following amendments to the Tamil Nadu Liquor Retail Vending (in Shops and Bars) Rules, 2003:—

AMENDMENT

In the said Rules for rule 7, the following rule shall be substituted, namely:-

"7. Renewal of licence.— The licence issued to the Corporation under rule 4 is renewable by the Commissioner of Prohibition and Excise on payment of annual Privilege fee of Rs.1,00,000/- (Rupees one lakh only), licence fee of Rs.1,000/- (Rupees one thousand only) and application fee of Rs. 100/- (Rupees one hundred only) on or before the 28th November."

[G.O. Ms. No.20, Home, Prohibition and Excise (VI), 29th March 2013.]

No. SROA-13/2013.—In exercise of the Powers conferred by Sections 17-C, 17-D, 21 and 22-D, read with Section 54 of the Tamil Nadu Prohibition Act, 1937 (Tamil Nadu Act X of 1937), the Governor of Tamil Nadu hereby makes the following amendment to the Tamil Nadu Liguor Retail Vending (in Shops and Bars) Rules, 2003:—

AMENDMENT

In the said Rules, after rule 9, the following rule shall be inserted, namely:-

"9A. Grant of privilege to run the bar,— The privilege of running bars may be granted to private parties by tender. The Board of the Corporation may decide the upset price and other terms and conditions of tender, from time to time, with the prior approval of the Commissioner of Prohibition and Excise. The Corporation, as agency shall collect the tender amount from the successful tenderers and remit the same to the Government on or before the 25th of the following month and the Corporation may retain 1% of the amount so collected as agency commission".
