**Amendment to the Tamil Nadu Co-operative Societies Rules**

No. SRO A-14/2013.—In exercise of the Powers conferred by sub-section (1) and (2) of Section 180 of the Tamil Nadu Co-operative Societies Act, 1983 (Tamil Nadu Act 30 of 1983), the Governor of Tamil Nadu hereby makes the following amendment to the Tamil Nadu Co-operative Societies Rules 1988:—

In the said Rules in rule 85, in the first proviso to sub-rule (2) for clause (iii) the following shall be substituted, namely:—

"(iii) rupees one lakh fifty thousand in the case of an apex society, unless, the prior sanction of the Registrar is obtained."
