Appointment of Managing Directors in certain Co-operative Societies and Delegation of powers to the Additional Registrar of Co-operative Societies, Chennai Region and to the Regional Joint Registrar of Co-operative Societies for certain period under the Tamil Nadu Co-operative Societies Act.

No.II(2)/CFCP/386/2013—Under clause (iii) of sub-section (7) of Section 33 of the Tamil Nadu Co-operative Societies Act, 1983 (Tamil Nadu Act 30 of 1983), the Governor of Tamil Nadu hereby notifies the Rural Banks and Employees' Credit Societies which have an annual turnover of not less than Rupees five crores and continuously made profit for not less than three years as per the audited accounts, for the purpose of appointment of Managing Directors by the Government.

# Appointment of Certain Experts/Scientists to the Appellate Authority of Tamil Nadu Pollution Control Board.

No.II(2)/EF/388/2013—Environment Control-Adjudication of disputes relating to Environment Pollution-Appointment of two Experts/Scientists to the Appellate Authority of Tamil Nadu Pollution Control Board for adjudication of disputes relating to Environment and Pollution Control-Orders-Issued.

The following Government Order is published.

Order No. 66, Environment and Forests (EC-1), 7th May 2013, சித்திரை 24, விஜய, திருவள்ளுவர் ஆண்டு– 2044.

Section 28 of the Water (Prevention and Control of Pollution) Act 1974 and Section 31 of Air (Prevention and Control of Pollution) Act 1981 provide that the State Government may constitute a State Appellate Authority consisting of one or three persons as it may think, fit to be appointed to help in the adjudication of disputes relating to Environment and Pollution.

- 2. In Pursuance of the orders of the Supreme Court in its Judgment in Civil Appeal No. 368-371 of 1999 of SLP (Civil) No. 10317-10320/98 and Civil Appeal Nos. 372, 373/99 in SLP (Civil) No. 10380 & 13380/98 the Authority has been composed of a retired Judge of High Court as Chairman and Experts/Scientists in the field of Pollution Control as Members.
- 3. Accordingly the Appellate Authority for Tamil Nadu Pollution Control Board was constituted in the G.O. first read above. In the G.O. second read above the Appellate Authority of Tamil Nadu Pollution Control was constituted under the Chairmanship of Justice K. Sampath Kumaran (Retd. High Court Judge) consisting two members for a tenure of three years, to help in the adjudication of disputes relating to Environment and Pollution. Subsequently in the Government order 4th read above, orders were issued extending the tenure of the Appellate Authority for a further period of three years from 19th February 2010. Hon'ble Justice K. Sampath Kumaran, Chairman, Appellate Authority of Tamil Nadu Pollution Control has relinquished his assignment as Chairman, Appellate Authority of Tamil Nadu Pollution Control with effect from 19th September 2011 and subsequently G.O. fifth read above Justice T.V. Masilamani, retired Judge of Madras High Court was appointed as Chairman of Appellate Authority for Tamil Nadu Pollution Control Board for adjudication of disputes relating to Environment and Pollution

Control and Dr. S. Thayumanavan and Dr. G.B. Jayaprakash Narain who were the members of the authority already were allowed to continue to be members of the Appellate Authority up to 18th February 2013 in G.O. (Ms.) No. 23, Environment and Forests (EC-1), Department, dated 24th January 2012.

- 4. The tenure of the Appellate Authority expired on 18th February 2013. Hence tenure of the Appellate Authority has to be extended for a further period of three years from 19th February 2013 and two members have to be appointed for the Appellate Authority since the existing members have already completed a period of six years.
- 5. The Government after careful consideration extend the tenure of the Appellate Authority of Tamil Nadu Pollution Control Board for adjudication of disputes relating to Environment and Pollution Control for a further period of 3 years from 19th February 2013. The Government has also allow the present Chairman of Appellate Authority Justice T.V. Masilamani, retired Judge of Madras High Court to complete his tenure period of 3 years from 24th January 2012.
