BOUNDARIES

North.—Starting from tri-junction point of Survey Numbers 546, 547 and 552 of No.168 Palanjur Village, the boundary runs generally eastwards along the southern sides of Survey Numbers 547, 548, 549, 550 and 551 of Palanjur Village and meets south west corner of Survey Number 954 of V.No.165, Thamarankottai Village, which is also bi-junction of Survey Number 529 of 186, Palanjur Village and Survey Number 964 of Thamarankottai Village and runs generally eastwards along the southern sides of Survey Field Numbers 964, 965, 966, 968 and 968, western and southern sides of Survey Field Numbers 969 (all of Thamarankottai Village) to the southern corner of Survey Field Number No. 969 which us also a bi-junction of the Survey Field Number 969 of Tharnarankottai Village and Survey Field Number 116 of No. 71, T. BOUNDARIES

I. Boundary description of Kodiakadu Extension Bit IV:

North—Starting from the tri-junction of Survey Numbers 65-A-1 A, 65 A-1 B and Pt. Calimere Reserved Forest, the boundary runs east for a length of 1000 links on the southern side of the Pt. Calimere Reserved Forest and joins the tri-junction point of Survey Numbers 372, 373 and 65-A-1 B all of No. 133, Kodiakadu Village.

East—Thence the boundary runs towards southwest reaching the railway line on the western side of Survey Numbers 373, 374 and 375 and joins the tri-junction of Survey Numbers 375, 42 and 65-A-1 B all of No. 133, Kodiakadu village.

South—Thence the boundary runs west for a length of 144 links and joins the tri-junction point Survey Numbers 41, 42 and 65-A-1B all of No. 133, Kodiakadu Village.

South—Thence the boundary turns towards west and runs along the northern side of Survey Numbers 223, 222, 195, 183 and 170 and reaches the tri-junction point of Survey Numbers 169, 170 and 65-B-1 all of No. 133, Kodiakadu Village.

West—Thence the boundary runs generally north along the eastern side of Survey Number 69 (part) of eastern side of No. 149, southern, eastern and northern side of Survey Number 65 B-3 part of eastern side of Survey Number 149 and reaches the tri-junction point Survey Numbers 65 B-1, 149 and 56, all of No. 133, Kodiakadu Village. Thence the boundary runs along the southern and eastern sides of Survey Number 56, southern sides of Survey Number 52 southern and eastern side of Survey Number 51 southern eastern and northern sides of Survey Number 65 B-2. Thence runs along the eastern side of Survey Numbers 375 and 374 and 373 and reaches the starting point.

III. Boundary description of Kodiakadu Reserve Forest:
