Enhancement of existing powers of Range Officer to Collect the compounding fees towards the Forest Offences not Exceed to Rs. 500/- under the Tamil Nadu Forest

[G.O. Ms. No. 60, Environment and Forests (FR.14), 26th April 2013.]

No. II(2)/EF/414/2013.—In exercise of the powers conferred by clause (d) of Section 59 of the Tamil Nadu Forest Act, 1882 (Tamil Nadu Act V of 1882) and in supersession of all the previous Notifications issued on the subject under the said clause (d) of Section 59 of the said Act, the Governor of Tamil Nadu hereby invests the forest rangers in all the forest divisions having territorial jurisdiction with the power under Section 55 of the said Act to accept compensation for forest offences arising within their respective ranges, provided that the value of the property involved in the offence does not exceed rupees five hundred in each case.

Order: No. 20, Home (Prison-IV), 29th May 2013.

In the G.O. first read above, the Government have issued orders notifying the Cheyyar Sub-Jail as 'Special Camp' to accommodate the inmates of Chengalpattu Special Camp.

- 2. The Inspector General of Police, Intelligence (Internal Security), 'Q' Branch CID, Chennai in his letter second read above has stated that the Special Camp. Cheyyar was functioning from 19-01-2005 to 24-08-2006 and eleven ENDLF cadres were accommodated in Cheyyar Special Camp. These inmates were sent back to Srilanka at their own willingness. Subsequently, the Cheyyar Special Camp was handed over to Prison Department on 01-04-2011. Since then, this is functioning as Sub-Jail. After renovation works are completed, the Sub-Jail, Cheyyar may be handed over to the District Administration for use as "Special Camp for accommodating Srilankan Tamils lodged in Chengalpattu Special Camp.
- 3. The Inspector General of Police, Intelligence (Internal Security), 'Q' Branch CID, Chennai in his letter third read above has stated that the Additional Director General of Police/Inspector General of Prisons, Chennai is pursuing the matter to convert Chengalpattu Special Camp into District Prison for accommodating the Prisoners now lodged in Central Prison, Puzhal in order to ease the problems faced during the escort of prisoners from Central Prison, Puzhal to various courts for their regular hearing in respective districts. Hence, it becomes necessary to shift the inmates of Chengalpattu Special Camp to Cheyyar Special Camp.
- 4. The Government after careful consideration have decided to accept the above proposal. Accordingly, the Government hereby orders that the Cheyyar Sub Jail be notified as "Special Camp" Cheyyar to accommodate the inmates of Chengalpattu Special Camp, against whom orders have been issued under Section 3(2)(e) of the Foreigners, Act, 1946, to restrict their free movement in the state.
- 5. The Additional Director General of Police/Inspector General of Prisons shall make necessary arrangements for handing over the Sub Jail, Cheyyar to the Collector of Tiruvannamalai immediately. The Collector of Tiruvannamalai

will take administrative and operation control of the Special Camp, Cheyyar.

6. The Inspector General of Police, Intelligence (Internal Security), 'Q' Branch CID, Chennai shall send necessary proposals to the Government in Public Department for issuing fresh orders under Section 3(2) (e) of Foreigners, Act in respect of inmates of Chengalpattu Special Camp for transferring them to 'Special Camp' Cheyyar.
