FINANCE DEPARTMENT

Amendments to the Special Rules for the Tamil Nadu State Treasuries and Accounts Service.

*[G.O. Ms. No. 219, Finance (Treasuries and Accounts-I), 1st July 2013,
Aani 17, Vijaya, Thiruvalluvar Aandu-2044.]*

No.SRO B-23/2013.—In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India, the Governor of Tamil Nadu hereby makes the following amendments to the Special Rules for the Tamil Nadu State Treasuries and Accounts Service (Section 28-A in Volume II of the Tamil Nadu Services Manual, 1969).

2. The amendment hereby made shall be deemed to have come into force on the 5th January 1985.

AMENDMENTS

In the said Special Rules:

(1) in rule 2 the following Classes and Categories of posts shall be inserted, namely:-

Class-I A

Category 1 : Joint Director

Category 2 : "Pay and Accounts Officer"

(In the cadre of Joint Director)

(2) in rule 3, in the Table under sub-rule (a) the following class and entries shall respectively be inserted namely:—
"Class I-A : Promotion from among the holders of the posts in Class II",

(3) in rule 5, the following Class and entries shall respectively be inserted, namely:-

"Class I-A By Promotion Must have put in a minimum service of one year as Treasury Officer in a District Treasury".

No.SRO B-24/2013.—In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India, the Governor of Tamil Nadu hereby makes the following amendments to the Special Rules for the Tamil Nadu State Treasuries and Accounts Service (Section 28-A in Volume II of the Tamil Nadu Services Manual, 1969).

2. The amendments hereby made shall be deemed to have come into force on the 16th June 1995.

AMENDMENTS

In the said Special Rules, in rule 2,

(1) Under Class II,

(a) In Category 2, for the expression "Pay and Accounts Officer", the expression "Personal Assistant (Administration) to the Commissioner of Treasuries and Accounts" shall be substituted;

(b) in Category 3, for the expression "Selection Grade Accounts Officer", the expression "Personal Assistant (Treasury Control) to the Commissioner of Treasuries and Accounts" shall be substituted;

(c) in Category 4, for the expression "Selection Grade Treasury Officer", the expression "Pension Pay Officer" shall be substituted;

(d) after "Category 4: Selection Grade Treasury Officer" as so substituted as Pension Pay Officer the following Category and expression shall be added, namely:-

"Category 5. Assistant Superintendent of Stamps";

(2) under Class III, the expression "Category 3 – Assistant Superintendent of Stamps" shall be omitted;

(3) for rule 4, the following rule shall be substituted, namely:-

"4. Appointing Authority

The Principal Secretary / Commissioner of Treasuries and Accounts shall be the appointing authority in respect of the posts in Class II, Class III and Class III-A from among the persons in the panel approved by the Government and in respect of Class IV."

(4) for rule 10, the following rule shall be substituted, namely:-

"10. Postings and Transfer

Postings and Transfers of the Officers in Class II, Class III, Class III A and Class IV shall be made by the Principal Secretary / Commissioner of Treasuries and Accounts".

No.SRO.B-25/2013-In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India, the Governor of Tamil Nadu hereby makes the following amendments to the Special Rules for the Tamil Nadu State Treasuries and Accounts Service (Section 28-A in Volume II of the Tamil Nadu Services Manual, 1969).

2. The amendments hereby made shall be deemed to have come into force on the 10th February 1995.

AMENDMENTS

In the said Special Rules:-

(1) in rule 2, after Class III and the entries there under, the following Class and entry shall be inserted, namely:-

"Class-III - A

"Additional Treasury Officer";

(2) in rule 3, in the Table under sub-rule (a) after "Class III" in column (1) and the corresponding entries in Column (2) thereof, the following Class and entries shall, respectively be added namely:-

"Class III – A Recruitment by transfer from among the holders of the posts of Senior Superintendent and Assistant Treasury Officers in Category 2 of the Tamil Nadu Treasuries and Accounts Subordinate Service".

No.SRO B-26/2013.—In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India, the Governor of Tamil Nadu hereby makes the following amendments to the Special Rules for the Tamil Nadu State Treasuries and Accounts Service (Section 28-A in Volume II of the Tamil Nadu Services Manual, 1969).

2. The amendments hereby made shall be deemed to have come into force on the 7th December 2000.

AMENDMENTS

In the said Special Rules, in rule 5, in the Table, in Column (3),—

(i) For the expression "(4) Must have passed the Accountancy Lower Grade", against the expressions "Recruitment by transfer from among the Sub-Treasury Officers and Superintendent in the Treasuries and Pay and Accounts Offices" in column (2), and the expression "Class IV" in column (1), the following expression shall be substituted, namely:-

"(4) Must have passed the Accountancy Lower Grade:

Provided that the person who possess the B.Com degree shall not be required to pass the Accountancy Lower Grade Examination";

(ii) For the expression "(3) Must have passed the Accountancy Lower Grade" in column (3), against the expression "Class IV" in column (1), and the corresponding entries in column (2) thereof, the following expression shall be substituted, namely:-

"(3) Must have passed the Accountancy Lower Grade:

Provided that the person who possess the B.Com degree shall not be required to pass the Accountancy Lower Grade Examination";

Amendments to Ad hoc Rules relating to the Post of Director of Public Libraries in Tamil Nadu Educational Service.

No. SRO B-27/2013.—In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India, the Governor of Tamil Nadu hereby makes the following amendments to the rules published with the Education Department Notification SRO No. B-90/74 at pages 101-102 of Part III—Section 1(b) of the *Tamil Nadu Government Gazette*, dated the 13th March 1974.

2. The amendments hereby made shall come into force on 1st July 2013.

AMENDMENTS

In the said Rules.-

(1) for rule 3, the following rule shall be substituted, namely:-

“3. *Appointment*.—Appointment to the post shall be made as follows:—

- (i) by promotion from the post of Joint Director of Public Libraries; or
- (ii) by transfer from Class I in the said Service; or
- (iii) by recruitment by transfer from any other service; or
- (iv) by direct recruitment, if a qualified candidate is available for appointment by any of the above methods;”

(2) for rule 4, the following rule shall be substituted, namely:-

“4. *Qualifications*.—(a) *Age*.—No person shall be eligible for appointment to the post by direct recruitment, if he has completed or will complete 45 years of age on the first day of July of the year in which the selection for appointment is made or notification issued, as the case may be.

(b) *Other qualification*.—No person shall be eligible for appointment to the post specified in column (1) of the Table below, unless he possesses the qualifications specified in the corresponding entries in column (2) thereof.

THE TABLE

<i>Methods of appointment</i>	<i>Qualifications</i>

(a) By promotion or by transfer	(i) Master's degree in Library Science or Library and Information Science; and (ii) Must have rendered service for a period of not less than five years in a Library after obtaining the Masters degree in Library Science or Library and Information Science.
(b) By recruitment by transfer	(i) Master's degree in Library Science or Library and Information Science; and (ii) Must have rendered service for a period of not less than seven years in a University or College Library or any Public or Government Library in the post carrying a Pay Band not lower than that of PB3 (i.e) Rs.15600-39100+GP 6600, after obtaining the Master's degree in Library Science or Library and Information Science.

THE TABLE

<i>Methods of appointment</i>	<i>Qualifications</i>
(1)	(2)
(c) By direct recruitment	(i) Master's degree in Library Science or Library and Information Science; and (ii) Must have rendered service for a period of not less than ten years in a Library after obtaining the Master's degree in Library Science or Library and Information Science".;

(3) for rule 6, the following rule shall be substituted, namely:-

"6. Probation.—Every person appointed to the post by direct recruitment shall, from the date on which he joins duty, be on probation for a total period of two years on duty within a continuous period of three years:

Provided that every person appointed to the post by recruitment by transfer shall, from the date on which he joins duty be on probation for a total period of one year on duty within a continuous period of two years".
