Amendments to the Special Rules for the Tamil Nadu Ex-servicemen's Welfare Service

[G.O. Ms. No. 7, Public (Ex-Ser), 3rd January 2013, நந்தன, மார்கழி 19, திருவள்ளுவர் ஆண்டு–2043.]

No. SRO B-1/2013.—In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India, the Governor of Tamil Nadu hereby makes the following amendments to the Special Rules for the Tamil Nadu Ex-servicemen's Welfare Service (Section 25-B in Volume II of the Tamil Nadu Services Manual, 1969).

2. The amendment hereby made shall come into force on and from 03-01-2013.

AMENDMENTS

In the said Special Rules,-

(I) in rule 2, in the Table, - (i) after entry (ii) in column (2) against the category "3-Assistant Director of Ex-servicemen's Welfare" in column (1), the following entry shall be added, namely:—

"OI

- (iii) By recruitment by transfer from among the holders of the posts of Welfare Organiser in the Department of Ex-servicemen's Welfare".
- (ii) for the Explanation in column (2), against the category "3 Assistant Director of Ex-servicemen's Welfare" in column (1), the following explanation shall be substituted, namely:—

Explanation:—The ratio between direct recruitment and recruitment by transfer from the post of Superintendent and Welfare Organiser in the department of Ex-servicemen's Welfare for the post of Assistant Director of Ex-servicemen's Welfare shall be 1:1:1. However, when no qualified candidates are available for appointment by recruitment by transfer, direct recruitment shall be resorted to fill up such vacancies also.

- (2) In rule 3, in the Table, for the entry (2) in column (3), against the category "3. Assistant Director of Ex-servicemen's Welfare" in column (1), and against the entry "Recruitment by transfer" in column (2), the following entry shall be substituted, namely:—
- "(2) Must have served either as Superintendent or as Assistant Secretary in the Department of Ex-servicemen's Welfare for a period of not less than three years or as Welfare Organiser in the Department of Ex-servicemen's Welfare for a period of not less than six years".
