Class II-Other Members sub-section (b) (2) of Section 24 under Chapter IV of the Bharathidasan University Act, 1981-TWO Members elected by teachers of affiliated colleges, other than principals, from among themselves who are members of the Senate in accordance with the system of proportional representation by means of the single transferable vote.

Out of the above vacancies one member has already been elected whose tenure is upto 26-12-2014. Election is to be conducted for one vacancy for the residual period upto 26-12-2014. This election is conducted for the casual vacancy.

Nominations are invited in the prescribed form which can be obtained from the Registrar i/c and Returning Officer on a requisition and submission of a Demand Draft for Rs. 500/- (Five Hundred only) drawn in favour of Bharathidasan University, Tiruchirappalli on or after the date of notification, i.e., 9th October 2013 with a stamped self-addressed envelope to the value of Rs. 25/- (Rupees twenty five only) or in person.

Nomination paper shall be enclosed in an envelope superscribed as follows, as the case may be:—

The Members are requested to send their nomination by Registered Post (with Acknowledgement due) so as to reach the Registrar i/c and Returning Officer within the date and hour fixed or delivered to the Registrar i/c and Returning Officer either in person or by a messenger within the date and hour fixed.
