Amendments to Adhoc Rules Relating to the Post of Block Health Supervisor in Tamil Nadu Public Health Subordinate Services.

[G.O. Ms. No. 231, Health and Family Welfare (L1), 17th October 2013, Purattasi-31, Vijaya, Thiruvalluvar Aandu - 2044.]

No. SRO B-34/2013.—In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India, the Governor of Tamil Nadu hereby makes the following amendments to the Rules issued with the Health and Family Welfare Department Notification No. SRO B-223/91, published at page 176 of Part III-Section 1 (b) of the *Tamil Nadu Government Gazette*, dated the 4th September 1996, as subsequently amended.

2. The amendments hereby made shall be deemed to have come into force on the 11th September 1995.

In the said Rules,—

1. in rule 3, for the expression “ Multipurpose Health Supervisor”, the expression “Health Inspector Grade-I” shall be substituted;

2 in rule 5, for the expression “ Multipurpose Health Supervisor”, the expression “Health Inspector Grade-I” shall be substituted;

Amendments to Adhoc Rules - Relating to the Post of Multipurpose Health Workers (Male) - Multipurpose Health Supervisor (Male) - Block Health Supervisor in Tamil Nadu Public Health Subordinate Services.

No. SRO B-35/2013.—In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India, the Governor of Tamil Nadu hereby makes the following amendment to the Rules issued with the erstwhile Health, Indian Medicine and Homeopathy and Family Welfare Department Notification No. SRO B-301/89, published at pages 208-209 of Part III-Section 1 (b) of the *Tamil Nadu Government Gazette*, dated the 6th September 1989, as subsequently amended.

AMENDMENTS

In the said Rules,—

1. in rule 1, for the expression “Health Inspector Grade-II” the expression “Multi Purpose Health Worker (Male)” shall be substituted;

2. In rule 3, for item (ii), the following item shall be substituted, namely:—

(ii) by recruitment by transfer from the Tamil Nadu Basic Service under the control of the Director of Public Health and Preventive Medicine;

3. In rule 4, for the expression “ the Health Officer of the Unit concerned”, the expression “the Deputy Director of Health Services of Health Unit District concerned”. shall be substituted;

4. in rule 5,—

(1) in sub-rule (a), for the expression “Twenty eight years”, the expression “thirty years” shall be substituted;

(2) for sub-rule (b), the following sub-rule shall be substituted, namely:—

“(b) **Other Qualifications.**—No person shall be eligible for appointment to the post by the method specified in column (1) of the Table below unless he possesses the qualifications specified in the corresponding entries in column (2) thereof:—

1. By direct recruitment	(i) Must have passed plus two with Biology or Botany and Zoology. (ii) Must have passed Tamil language as a subject in S.S.L.C level. (iii) Must possess one year Multipurpose Health Worker (Male) training course certificate granted by the Director of Public Health and Preventive Medicine conducted in the Government Training Centre or Institutions approved by the Director of Public Health and Preventive Medicine.
2. By recruitment by transfer from Tamil Nadu Basic Service under the control of the Director of Public Health and Preventive Medicine.	(i) Must have passed plus two with Biology or Botany and Zoology. (ii) Must have passed Tamil language as a subject in the S.S.L.C. Level. (iii) Experience for a period of not less than ten years in the category of Tamil Nadu Basics Service under the control of the Director of Public Health and Preventive Medicine. (iv) Must possess one year Multipurpose Health Worker (Male) training course certificate granted by Director of Public Health and Preventive Medicine conducted in the Government training centre or Institutions approved by the Director of Public Health and Preventive Medicine.

5. for rule 7, the following rule shall be substituted, namely;—

“7 Transfer and Postings.— (i) The Holders of the post shall be posted anywhere in Health Sub-Centre in the State of Tamil Nadu.

(ii) The Authority competent to transfer the holders of the post, shall be the Director of Public Health and preventive Medicine.”;

6. to rule 8, the following proviso shall be added, namely:-

“Provided that there shall be paid to the holder of the post, a monthly pay calculated in the Scale of pay of Rs.5200-20200 with Grade pay of Rs. 2400.”,

7. after rule 8, the following rule shall be added, namely:—

“9 Saving Clause.- Nothing contained in these amendments shall adversely affect any person holding the post on the date of issue of this order”.

In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India, the Governor of Tamil Nadu hereby makes the following amendments to the Rules issued with the erstwhile Health, Indian Medicine and Homeopathy and Family Welfare Department Notification No. SRO B-303/89, published at pages 209-210 of Part III-Section 1 (b) of the *Tamil Nadu Government Gazette*, dated the 6th September 1989, as subsequently amended.

In the said Rules,-

AMENDMENTS

1. in rule 1, for the expression “Health Inspector Grade-I”, the expression “Multipurpose Health Supervisor (Male)” shall be substituted;

2. for rule 3, the following rule shall be substituted, namely:—

"3 Appointment. - Appointment to the post shall be made by promotion from the posts of Multipurpose Health Worker (Male) under the Multipurpose Health Worker Scheme and Laboratory Technician Grade-III:

Provided that the appointment by the method of promotion from the above two posts shall be in the ratio of 3:1.";

3. for rule 5, the following rule shall be substituted, namely:—

"5. **Qualifications.**- No person shall be eligible for appointment to the post by the method specified in column (1) of the Table below unless he possesses the qualifications specified in the corresponding entries in column (2) thereof:—

	(4) Must have Undergone one year Multipurpose Health Worker (Male) Training Course Certificate granted by the Director of Public Health and Preventive Medicine in Government Training Centres or Institutions approved by the Director of Public Health and Preventive Medicine; and	
	(5) Must possess Multipurpose Health Supervisor (Male) Certificate on successful completion of one month in service training within two years from the date of promotion as multipurpose Health Supervisor (Male) conducted by the Director of Public Health and Preventive Medicine.	

4. for rule 6, The following rule shall be substituted, namely:—

"6. **Transfer and Postings.**— (i) The Holders of the post shall be posted at Primary Health Centres, Schemes such as Filaria Control, Research *cum* Action Project, Immuniation, Vector Borne Disease Control, Epidemic Control and in any other Schemes, State Headquarters, Office of the Deputy Director of Health Services, Government Hospitals and anywhere in the State.

(ii) The authority competent to transfer the holders of the post shall be the Director of Public Health and Preventive Medicine.";

5. to rule 7, the following proviso shall be added, namely:—

"Provided that there shall be paid to the holder of the post, a monthly pay calculated in the scale of pay of Rs.9300-34800 with Grade Pay of Rs. 4200."

No. SRO B-37/2013.

In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India, the Governor of Tamil Nadu hereby makes the following amendments to the Rules issued with the Health and Family Welfare Department, Notification No. SRO B-223/91, published at page 176 in Part III-Section 1 (b) of the *Tamil Nadu Government Gazette*, dated the 4th September 1991, as subsequently amended.

AMENDMENTS

In the Said Rules,-

1. in Rule 3, for the expression "Health Inspector Grade-I", the expression "Multipurpose Health Supervisor (Male)" shall be substituted;

2. for rule 5, the following rule shall be substituted, namely:-

"5. **Qualifications.**- (i) No person shall be eligible for appointment to the post unless he possess the experience for a period of not less than five years in the post of Multipurpose Health Supervisor (Male) under Multipurpose Health Workers Scheme;

(ii) Must possess Block Health Supervisor certificate awarded on successful completion of one month in service training conducted by the Director of Public Health and Preventive Medicine,";

3. to rule 6, the following proviso shall be added, namely:-

"Provided that there shall be paid to the holder of the post, a monthly pay calculated in the scale of pay of Rs.9300-34800 with Grade Pay of Rs.4500."

4. after rule 6, the following rule shall be added, namely:-

"7. **Transfer and Postings.**- (i) The holders of the post shall be posted anywhere at Block level in the State; (ii) The authority competent to transfer the holders of the post shall be the Director of Public Health and Preventive Medicine.".
