#### Amendment to the Tamil Nadu Special Police Subordinate Service Rules.

[G.O. Ms. No. 827, Home (Pol. IX), 10th October 2013.]

No. SRO B-38/2013—In exercise of the powers conferred by sections 8 and 10 of the Tamil Nadu District Police Act, 1859 (Central Act XXIV of 1859) and sections 9 and 11 of the Chennai City Police Act, 1888 (Tamil Nadu Act III of 1888) read with the proviso to Article 309 of the Constitution of India the Governor of Tamil Nadu hereby makes the following amendment to the Tamil Nadu Special Police Subordinate Service Rules, 1978 (Section 44 in Volume-III of the Tamil Nadu Services Manual, 1986):—

2. The amendments hereby made shall be deemed to have come into force with effect on and from the 11th December 2006.

Amendments

In the Said Rules in rule 14:-

(1) in sub rule (a), in the tabular column:-

(a) in the second proviso in column (2) against the entry "Category 2 (Men and Women)" in column (1) after the expression "Ex-Servicemen" the following expression shall be inserted, namely:-

"and the Ex-personnel of the Central Para-Military Forces like Central Reserve Police Force, Central Industrial Security Force, Border Security Force and Indo-Tibetan Border Police;"

(b) in the second proviso in column (2) against the entry "Categories 4,5,6" in column (1), after the expression "Ex-Servicemen" the following expression shall be inserted, namely:----

"and Ex-personnel of Central Para-Military Forces like Central Reserve Police Force, Central Industrial Security Force, Border Security Force and Indo-Tibetan Border Police;"

(2) in sub-rule (f), in the tabular column, in the 'Explanation' in Column(2) against the "Category 6 Constables (men and women)" in column (1), after the expression "Ex-Servicemen" the following expression shall be inserted, namely:-

"and Ex-personnel of the Central Para-Military Forces".

#### Amendments to the Special Rules for the Tamil Nadu Police Service.

No. SRO B-39/2013—In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India, the Governor of Tamil Nadu hereby makes the following amendments to the Special Rules for the Tamil Nadu Police Service (Section 22 in Volume II of the Tamil Nadu Services Manual, 1969).

2. The amendments hereby made shall be deemed to have come into force with effect on and from the 30th September 2009.

(a) in column (2), against the entry "Category (1) Superintendent of Police (Technical)" in column (1), for the expression "Deputy Superintendent of Police (Technical)", the expression "Additional Superintendent of Police (Technical)" shall be substituted;

(b) in columns (1) and (2), after the entry "Category (1) Superintendent of Police (Technical)" in column (1) and the entries relating thereto in column (2), the following category and entry shall, respectively, be inserted, namely:—

"Category (1-A) Additional Superintendent of Police (Technical)" and "Promotion from the post of Deputy Superintendent of Police (Technical)".;

(3) in the proviso to rule 2-A, after the expression "Superintendent of Police (Technical)", the expression "and Additional Superintendent of Police (Technical)" shall be inserted;

(4) in rule 4, in sub-rule (F), in the TABLE,-

(i) in column (3), against the entries "Superintendent of Police (Technical)" in column (1) and " (i) Promotion" in column (2), for the expression "Deputy Superintendent of Police (Technical), the expression "Additional Superintendent of Police (Technical)" shall be substituted:—

(ii) in columns (1), (2) and (3), after the entry "Superintendent of Police (Technical)" in column (1) and the entries relating thereto in columns (2) and (3), the following entries shall, respectively. be inserted namely:—
