And under the heading 1. RESIDENTIAL USE ZONE, the Survey Numbers "68, 69, 70, 71/1A, 1B1, 1B2, 1C, 1D, 2, 3, 4A, 4B, 5A, 5B, 6A, 6B, 6C, 6D, 6E, 6F, 7A, 7B, 8, 9,10, 11A, 11B; 72/1, 2B, 4, 5, 6A, 6B, 6C and 85/3A1A1" shall be added.

CONDITIONS:

1. The Water bodies (i.e. Kuttai in S.F.No.58 of Eastern side and SF.No. 68 of Southern side) have not to be affected by means of discharging of waste water drainage from the proposed building.
2. The 9.0m approach road has to be formed by the applicant in his land, from the public access to the other person land in S.No.72/2A, 3A, 3B and the same should be handed over to local body by way of gift deed (or) to get consent letter from the owner of the private site in S.F.No. 72/2A, 3A, 3B regarding the formation of approach road.

Conferment of Powers

No. 202/2013.—In exercise of the powers conferred by Section 13 of the Code of Criminal Procedure 1973 (Central Act 2 of 1974) the High Court hereby appoints the following 12 Deputy Tahsildars, 8 in Namakkal and 4 in Nagapattinam District to undergo Magisterial Training for a period of **120** days from the date of assumption of charge and confers upon them the ordinary powers conferrable under this Code on a Judicial Magistrate to try such cases which were earlier triable and dealt with by an erstwhile Judicial Second Class Magistrate.
