READ:

From the Additional Director General of Police, Economic Offences Wing-II, Chennai Letter No. C1/13420/2012, dated 8-12-2012 and letter even No. dated 18-1-2013 and 8-4-2013.

Order No. 590, Home (Police XIX), 13th August 2013.

WHEREAS the Additional Director General of Police, economic Offences Wing has reported that a case in Crime No.168/ 2010 under section 457, 380 IPC was registered in Thirunavalur Police Station based on the complaint of Secretary to Thirunavalur Farmers Service Co-operative Society and later it was transferred to Villupuram Commercial Crime Investigation Wing – Criminal Investigation Department in Crime No.1/2011 under sections 408, 409, 468, 420, 471, 477 (A) read with section 109 Indian Penal Code and sections 414 and 461 IPC and the investigation has revealed that one Veerasundaram, who is a salesman and incharge of the Society's properties, conspired with one Sivakumar to do away with the gold jewels kept in the society's locker and the duo executed their operation and Veerasundaram gained entry into the society, broke open the bureau and took away 1790 sovereigns of gold jewels and Rs. 3,00,000/- cash from the locker and concealed them in the backyard of Sivakumar's house. Subsequently, Veerasundaram died and the whole property was inherited by Sivakumar, who took the jewels one by one and gave it to his friend Mothibai for disposal and thus Sivakumar got approximately Rs. 33,00,000/- and Thiru. Mothibai purchased 7 plots.

AND WHEREAS, the offence under section 420 Indian Penal Code is a scheduled offence under the Criminal Law Amendment Ordinance, 1944 (Central Ordinance XXXVIII of 1944) as amended by Tamil Nadu Act 47 of 1997;

AND WHEREAS, it is reported that the accused Mothibai at Farooklal and Sivakumar involved in the above misappropriation have acquired and are in possession of properties specified in the Schedule-I below in their names which are believed to have been procured by means of the said offence;

AND WHEREAS, the Deputy Superintendent of Police, Commercial Crime Investigation Wing – Crime Investigation Department, Chennai incharge Villupuram sub-division has requested the government to authorise, him to make an application in the Court of District Judge, Villupuram within the Local limits of whose jurisdiction the said accused ordinarily resides, for the attachment under the Criminal Law Amendment Ordinance, 1944, of the properties as detailed in the Schedule to this Order, which are believed to have been procured by means of the above said offence;

Now, THEREFORE, in exercise of the powers conferred by sub-section (1) of Section 3 of the Criminal Law Amendment Ordinance, 1944 (Central Ordinance XXXVIII of 1944), the

Governor of Tamil Nadu, after careful consideration of the materials placed before him hereby Authorizes the making of an application by the Deputy Superintendent of Police, Commercial Crime Investigation Wing – Crime Investigation Department, Chennai incharge Villupuram sub-division to the District Court, Villupuram for the attachment of the movable and immovable properties in the schedule-I, to this Order, which are procured by means of the aforesaid offence by the accused Mothibai @ Farooklal and Sivakumar who were involved in the Misappropriation of funds of Thirunavalur Farmers Service Co-operative Society, Villupuram District and also appoints the said Deputy Superintendent of Police, Commercial Crime Investigation Wing – Crime Investigation Departement to sign and verify such application.

- 2. The Additional Director of Police, Economic Offences Wing II, Chennai is directed to file and affidavit before the Jurisdictional District Judge under section 6 of the Criminal Law Amendment Ordinance, 1944 (Central Ordinance XXXVIII of 1944) for the attachment of the movable and immovable properties of malafide transferees mentioned in Schedule II of this order, which are believe to have been procured by means of the said offence.
- 3. The Government Pleader, Villupuram is requested to conduct the above case for attachment of the properties mentioned in Schedules to this order.

- (2) Classification of employees into class-I and class-II is based on physical capacity, skill, efficiency and out turn of work.
- (3) In case of piece rated workers, their daily total earning for 8 hours of work shall not be less than the daily rates of wages revised for that category of employees. In computing the above rates, a day's work is deemed to comprise of 8 working hours. If the employee is employed for less than 8 hours, wages have to be calculated proporitionately.
- (4) Dearness Allowance.—(1) In addition to the basic wages fixed above, the employees shall be paid Dearness Allowance as indicated below:—
- (i) The dearness allowance is linked to the average Chennai City Consumer Price Index number for the year 2010, that is 161 points (with base 2001=100) and for every rise of one point over and above 161 points an increase of 2.20 paise (Two rupees and twenty paise only) per day shall be paid as Dearness Allowance.
- (ii) The dearness allowance shall be calculated every yea on the first April on the basis of the average Consumer Price indices of the preceding twelve months, i.e. from January to December.

- iii) The first calculation shall thus be effective from the date of publication of this Notification in the *Tamil Nadu Government Gazette* based on the average Chennai City Consumer Price Index Number for the previous year.
- (2) Where the nature of work is the same, no distinction in the payment of wages shall be made as between men and women employees.
- (3) To arrive at monthly rates of wages, the daily rates of wages shall be multiplied by 30.
- (4) Wherever the existing wages are higher than the minimum wages fixed herin, the same higher wages shall be continued to be paid.

No. II(2)/PUEX/898/2013.—In the G.O. in the exsiting paragraph 3, after [Authority Letter No. 9 (52)/88/D(Res), dated 19-07-1989 from the Director to the Government of India, Ministry of Defence, New Delhi] the following shall be added:-

3. (i) The personnel who were in deputation in Army Postal Service for more than 6 (six) months prior to 14th April 1987 would also be considered as Ex-Servicemen with all consequential benefits.

In the G.O. Ms. No. 1110, Public (Ex-Servicemen) Department dated 16-12-2002, existing paragraph 4, the following shall be subsituted:-

4. In all cases, Ex-Recruits who were boarded out / released on medical grounds, and granted medical / disability pension with effect from 1-2-2006.
