Amendments to the Special Rules for the Tamil Nadu Registration Service

No. SRO B-43/2013.—In exercise of the powers conferred by the proviso of Article 309 of the constitution of India, the Governor of Tamil Nadu hereby makes the following amendments to the Special Rules for the Tamil Nadu Registration Service (Section 25 in Volume II of the Tamil Nadu Services Manual, 1969), as subsequently amended.

No. SRO B-44/2013.—In exercise of the powers conferred by the proviso to Article 309 of the constitution of India and of all other powers hereunto enabling, the Governor of Tamil Nadu hereby makes the following amendment to The General Provident Fund (Tamil Nadu) Rules:—

"(iii) When a person eligible, by means of nomination or otherwise as provided in clauses (i) or (ii), for a share of the amount standing to the credit of the subscriber dies before receiving the amount, such amount shall be payable to the remaining eligible persons in equal share."
