In exercise of the powers conferred under sub section (1) of Section 33 of Town and Country Planning Act, 1971 (Act No. 35 of 1972) The Commissioner of Town and Country Planning, in the Proceedings ROC No. 21323/2013 DP2, dated November 2013 proposes to make the individual draft variation for conversion of Industrial use into Residential use in New T.S.No.10/3, Ward-B, Block-20, with an Extent: 4848 Sq.m to the approved Udumalpet Detailed Development Plan No. 5, in Director of Town and Country Planning Proceedings in Roc. No. 25196/1970 DP4, dated 17th October 1970.

The said notification was published in Tamil Nadu Government Order No. 2269, Rural Development Department and Local Administration Department, dated 7th November 1971.

In exercise of the powers conferred by sub section (4) of Section 32 of the Tamil Nadu Town and Country Planning Act, 1971 (Tamil Nadu Act 35 of 1972), Government in the order G.O.(2D) No. 84, Housing and Urban Development UD 4(1) Department, dated 22-8-2013 has permitted to change of land use of survey numbers with condition making the following variation to the Master Plan for the Mamallapuram Local Planning Area, approved under the said Act and published in the G.O.Ms. No. 153 H & UD [UD4(2)], dated 20-06-2013, Notification No.II (2)/HOU/501/2013, at page No.481 of Part-II, Section 2 of the *Tamil Nadu Government Gazette* dated 17th July 2013.

VARIATIONS

In the said Master Plan, in the "LAND USE SCHEDULE" of Village 37, Kanathur Reddikuppam, under the heading

7. Agriculture Use Zone, the Survey Numbers the expression "18 to 20" shall be deleted and 18 (except 18/1, 2, 3, 8A, 8D, 10), 19 (except 19/1, 2, 3, 4, 6B) and 20 shall be substituted.

And under the heading 1. RESIDENTIAL USE ZONE, the Survey Numbers "18/1, 2, 3, 8A, 8B, 10; 19/1, 2, 3, 4, 6B" shall be added.

Conditions:

1. The conditions specified in the NOC of Thasildar, Chengalpattu in K.Dis.No.1753/2012/A1, dated 21st April 2012 has to be fulfilled.
2. The 9.0m approach road has to formed by the applicant in his land from the Public access to the Kulam Poramboke in S.No. 30/11 and Kulam Poramboke in S.No. 18/9 and the same should be handover to local body by way of gift deed at the time of applying Planning Permission.
