## Amendments to the Tamil Nadu Document Writers' Licence Rules

[G.O. Ms. No. 11, Commercial Taxes and Registration (M2), 15th February 2013,

No. SRO A-2/2013.—In exercise of the powers conferred by Section 89-B of the Registration Act, 1908 (Central Act XVI of 1908), the Governor of Tamil Nadu hereby makes the following amendments to the Tamil Nadu Document Writers' Licence Rules, 1982, as subsequently amended.

2. The amendments hereby made shall come into force on the 15th day of February 2013.

## AMENDMENTS

In the said Rules, in rule 7, in sub-rule (2),

(1) for the first proviso, the following proviso shall be substituted namely:-

“Provided that in the case of a person who had obtained a licence under the Tamil Nadu Copy Writers' Licence Rules, 1971, before 15-2-2013, whether renewed or not should have passed S.S.L.C. examination or its equivalent examination.” ; and

(2) for the third proviso, the following proviso shall be substituted, namely:-

“Provided also that persons who apply for the Document Writers' Licence Test should have taken Tamil as a subject, either as first language or second language, in the S.S.L.C. examination or its equivalent examination.”

## Amendment to the Tamil Nadu Factories Rules

No. SRO A-3/2013.—In exercise of the powers conferred by Section 112 of the Factories Act, 1948 (Central Act LXIII of 1948), the Governor of Tamil Nadu hereby makes the following amendment to the Tamil Nadu Factories Rules, 1950, the draft of the same have been previously published as required by Section 115 of the said Act.

## AMENDMENT

In the said Rules, in rule 98, in sub-rule (3), for the entry "(9) Association of Indian Engineering Industry", the entry "(9) Confederation of Indian Industry" shall be substituted.
