### Amendments to Special Rules for the Tamil Nadu Industries Service

[G.O. Ms. No. 10, Micro, Small and Medium Enterprises [EI (1)], 20th February 2014,

No. SRO B-21/2014.—In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India, the Governor of Tamil Nadu hereby makes the following amendments to the Special Rules for the Tamil Nadu Industries Service (Section 19 in Volume III of the Tamil Nadu Services Manual 1970):—

2. (i) The amendments 1 (a), 2(a) (i), 2(b)(i), 3 and 4(a) hereby made shall be deemed to have come into force on the 6th June 1991.

(ii) The amendments 1(b), 2(a) (ii), 2 (a) (iii), 2(b) (ii), 4(b), 4(c) and 4(d) hereby made shall be deemed to have come into force on the 31st August, 2000.

#### AMENDEMENTS

In the said Special Rules,—

1. in rule I, under the heading "Category 1",-

(a) the expression "Joint Director of Industries and Commerce (Rural Industries Projects)" shall be omitted;

(b) the expression "Joint Director of Industries and Commerce (Chemicals)" and the expression "Joint Director of Industries and Commerce (Electrical and Electronics)" shall be omitted;

2. In rule 2,-

(a) in sub-rule (a), in the tabular column,-

(i) under the heading "Posts" in the first column, for the expression "Joint Director of Industries and Commerce (Engineering) and Joint Director of Industries and Commerce (Rural Industries Project)", the expression "Joint Director of Industries and Commerce (Engineering)" shall be substituted;

(ii) the expression "Joint Director of Industries and Commerce (Chemicals)" in the first column and the corresponding entries relating thereto in the second column shall be omitted;

(iii) the expression "Joint Director of Industries and Commerce (Electrical and Electronics)" in the first column and the corresponding entries relating thereto in the second column shall be omitted;

(b) in sub-rule (b),-

(i) the expression "Joint Director of Industries and Commerce (Rural Industries Project)" shall be omitted

(ii) the expression "Joint Director of Industries and Commerce (Chemicals)" shall be omitted;

3. the proviso to rule 5 (A) shall be omitted;

4. in the ANNEXURE in the tabular Column,-

(a) under the heading "Category," the expression "Joint Director of Industries and Commerce (Rural Industries Project)" in the first column, shall be omitted;

(b) under the heading "Qualifications" for the entries in the third column against the Category "Joint Director of Industries and Commerce (Engineering)" in the first column, the following entries shall be substituted, namely:-

(a) (i) Degree in Mechanical or Electrical or Electronics or Instrumentation or Automobile or Chemical Engineering or a degree in Mining and Metallurgy or a Diploma in Automobile Engineering of the any University or Institution recognized by the All India Council for Technical Education or atleast a Second Class degree in any branch of Chemistry or in Industrial Chemistry or an Associateship Diploma of the Institute of Chemists (India) or M.Sc. Degree in Physics with Electronics as a special subject, or a Diploma in Mechanical or Electrical or Electronics or Automobile or Chemical Engineering or Mining and Metallurgy or Instrumentation issued by the Technical Diploma Examination Board, Madras (State Board of Technical Education and Training, Tamil Nadu) or by any other recognized Institution or Board; and

(ii) Must have served in Category 2 for a period of not less than three years;

(iii) the category "Joint Director of Industries and Commerce (Chemicals)" in the first column and the corresponding entries relating thereto in the second and third columns shall be omitted; and

(iv) the category "Joint Director of Industries and Commerce (Electrical and Electronics)" in the first column and the corresponding entries relating thereto in the second and third columns shall be omitted.

(iii) against the entry "Lecturer in Official Statistics" in column (1), the entries "By Transfer from the post of Assistant Director of Statistics" and "By Recruitment by Transfer from the post of Statistical Officer" in column (2) and the corresponding entries in column (3) thereof, shall be omitted.
