##### **Provisions for the Consolidation of Duty Chargeable in respect of issue of Insurance Policies by Life Insurance Corporation of India through its Branches in the State of Tamil Nadu for certain period under the Act.**

##### **Remission of the irrecoverable Balance Amount of Arrears of Tax Payable in respect of the contract carriage for certain period under the Tamil Nadu Motor Vehicles Taxation Act.**

*[G.O. Ms. No. 281, Home (Tr.I), 10th April 2014.]*

No.II(2)/HO/325/2014.—In exercise of the powers conferred by clause (1) of Section 20-A of the Tamil Nadu Motor Vehicles Taxation Act, 1974 (Tamil Nadu Act 13 of 1974), the Governor of Tamil Nadu hereby remits a sum of Rs. 25,935/- (Rupees Twenty five thousand nine hundred and thirty five only) being the irrecoverable balance amount of arrears of tax payable under the said Act, in respect of the contract carriage bearing Registration No. KA01A5656 for the period from 1-10-2001 to 31-12-2001.

This order does not require the concurrence of Finance Department *vide* its G.O. Ms. No. 519, dated 29-09-1997.
