Except as hereunder mentioned the Presidency court of Small Causes, Chennai will remain closed for the Summer Vacation, 2014 from 01-05-2014 to 01-06-2014 (both days inclusive).

The Summer vacation for the year 2014 of this Court will be from 01-05-2014 to 01-06-2014 (both days inclusive). The First turn will be from 01-05-2014 to 16-05-2014 and the Second turn of the vacation will be from 17-05-2014 to 01-06-2014.

**The Office of the Court of Small Causes, Chennai will function from Monday to Wednesday and Friday each week from 10 A.M. to 4.30 P.M on Thursday (i.e.) court sitting day, from 10 A.M. to 5.45 P.M. during the summer vacation 2014.**

**Tmt. S.D. Parimala, III Judge**, Court of Small Causes, Chennai (Transferred as II Judge, Court of Small Causes, Chennai) will be the Vacation Judge for First turn from 01-05-2014 to 16-05-2014.

**Tmt. S. Meena Kumari, IV Judge**, Court of Small Causes, Chennai (Transferred as III Judge, Court of Small Causes, Chennai) will be the Vacation Judge for Second turn from 17-05-2014 to 01-06-2014.

**Thiru. N. Sachidhanandam, XV Judge**, Court of Small Causes, Chennai will be the Additional Vacation Judge for First turn from 01-05-2014 to 16-05-2014. The Additional Vacation Judge will deal with Rent Control Original petitions.

**Tmt. B.S. Kalaivani, XIV Judge**, Court of Small Causes, Chennai will be the Vacation Officer for Second turn from 17-05-2014 to 01-06-2014.

**The Filling Section will be functioning on every Wednesdays and the sitting of the Judges will be on every Thursdays of the respective week during the summer vacation 2014.**

The Vacation Judges unless otherwise notified will sit on all Thursday of every week during the vacation, to dispose the emergent petitions. No fresh plaint petition, no Rent Control Appeals or other matters will be received during the period of vacation, unless it is urgent and it is accompanied by an application duly supported by an affidavit showing the urgency.

The Copyist Section of the Court of Small Causes will be kept open from Monday to Friday each week and between 10.30 A.M. to 3.00 P.M. for receiving copy application and for delivering the certified copies, which were already made ready and no fresh certified copy will not be made ready during the summer vacation.

The Nazir Section will function from Monday to Friday each week and Process Application will be received between 10.30 A.M. to 3.00 P.M. on Wednesdays, Warrants will be issued only on Wednesdays and Thursdays of the respective weeks, which were already filed and made ready. Warrants which are being filed on Wednesday will be made ready and will be issued only on the next days (*i.e.*) Thursday. If the warrants returned for reasons, (*i.e.* since police protection not available), the same will be re-issued only on next Wednesday or Thursday, if the Petitioner/Decree Holder wants to execute the Warrants and makes such endorsement.

Since 01-05-2014 (Thursday) falls on Public Holiday Process Application will be received on 02-05-2014. Process already filled and warrant made ready will be issued only on 02-05-2014 during the first week only.

The Office of the Registrar will be kept open from Monday to Friday each week but the urgent matters will be received on Wednesdays during the vacation and such matters will be posted before the Vacation Judges and the Additional Vacation Judges for the hearing on the succeeding Thursday in the open court.

Money will be received in the Treasury Section on Wednesdays and Thursdays of every week and money will be paid out only on Thursdays during the Vacation, when the Vacation Judges are holding courts and on orders made by the vacation Judges for such payments. Since 01-05-2014 (Thursday) falls on Public Holiday, the Treasury Section will receive money on 02-05-2014 (Friday), during the first week only. In the remaining weeks money will be received and paid as mention above.

With a view to avoid difficulty to the parties / petitioners and the members of the staff, suit, Rent Control Original Petition, Rent Control Appeals and the petitions of other proceedings which are to be filed on the re-opening day, will also be received and returned. The case bundles will be made available for taking returns in the regular courts between 11.00 A.M. and 3.00 P.M. on Thursday only.
