**Draft Amendments to the Tamil Nadu Contract Labour (Regulation and Abolition) Rules.**

*[G.O. (D). No. 631, Labour and Employment (H1), 11th December 2013.]*

No.SRO A-1/2014.—The following draft amendments to the Tamil Nadu Contract Labour (Regulation and Abolition) Rules, 1975 which it is proposed to make in exercise of the powers conferred by Section 35 of the Contract Labour (Regulation and Abolition) Act, 1970 (Central Act of 37 of 1970), are hereby published for information of all persons likely to be affected thereby, published as required by sub-section (1) of the said Section 35 of the said Act.

2. Notice is hereby given that the draft amendments will be taken into consideration on or after the expiry of the period of two months from the date of publication of this Notification in the *Tamil Nadu Government Gazette* and that if any objection or suggestion which may be received from any person with respect thereto before the expiry of the above said period will be considered by the Government of Tamil Nadu. Objections and suggestions, if any, should be addressed to the "Secretary to Government, Labour and Employment Department, Chennai-600 009" through the Commissioner of Labour, Chennai-600 006.

**Draft Amendments**

In the said Rules,—

(1) in rule 81-A, for the expression, "Form XXVI (in duplicate)" the expression "Form XXX (in duplicate)" shall be substituted;

(2) Form XXVI referred to under rule 81-A shall be omitted;

## SOCIAL WELFARE AND NUTRITIOUS MEAL PROGRAMME DEPARTMENT

**The Tamil Nadu State Commission for Women (Honorarium, Allowances and Conditions of Service of Chairperson and Members) Rules.**

[G.O. Ms. No.105, Social Welfare and Nutritious Meal Programme(SW-3), 18th December 2013,

No.SRO A-2/2014.—In exercise of the powers conferred by sub-sections (1) and (2) of Section 20 read with sub-section (2) of Section 4 of the Tamil Nadu State Commission for Women Act, 2008 (Tamil Nadu Act 31 of 2008), the Governor of Tamil Nadu hereby makes the following rules, namely:—

## RULES

- 1. Short title and commencement.-** (1) These rules may be called the Tamil Nadu State Commission for Women (Honorarium, Allowances and Conditions of Service of Chairperson and Members) Rules, 2013.
- (2) These rules shall come into force on the 18<sup>th</sup> December 2013.
- 2. Definitions.-** In these rules, unless the context otherwise requires.—
  - (a) "Act" means the Tamil Nadu State Commission for Women Act, 2008 (Tamil Nadu Act 31 of 2008);
  - (b) "Chairperson" means the Chairperson of the Commission;
  - (c) "Member" means a member other than the Member-Secretary and an *Ex-officio* Member of the Commission.
- 3. Honorarium of Chairperson and Members.-** (1) The Chairperson shall be paid Rupees Twenty five thousand per month as Honorarium.
- (2) The Members shall be paid Rupees one thousand per sitting as Honorarium.
- 4. Other allowances and Conditions of service of Chairperson and Members.—**
  - (1) The Chairperson shall be paid House Rent Allowance of Rupees Two Thousand and Five Hundred per month.
  - (2) The Chairperson, shall be eligible for office telephone with monthly ceiling of 2500 calls including free calls and also eligible for residential telephone with monthly ceiling of 300 calls including free calls .The Chairperson shall be paid a sum of Rupees One thousand and two hundred per month towards the reimbursement of cell phone call charges for using her cell phone for official purposes.
  - (3) The Chairperson shall be eligible for Leave Travel Concession on par with Group 'A' Officers of the Government.
  - (4) The Chairperson and Members shall be eligible for Travelling Allowance and Daily Allowance as per the orders issued in G.O.(Ms)No.551, Finance (Allowances) Department, dated 03-11-2004.

No.SRO A-3/2014.—In exercise of the powers conferred by sub-sections (1) and (2) of Section 20 read with sub-section (3) of Section 8 of the Tamil Nadu State Commission for Women Act, 2008 (Tamil Nadu Act 31 of 2008), the Governor of Tamil Nadu hereby makes the following rules, namely:—

**RULES**

**1. Short title and commencement.-** (1) These rules may be called the Tamil Nadu State Commission for Women (Allowances Payable to Co-opted Members of Committees) Rules, 2013.

(2) These rules shall come into force on the 18<sup>th</sup> December 2013.

**2. Definitions.—**In these rules, unless the context otherwise requires.—

(a) "Act" means the Tamil Nadu State Commission for Women Act, 2008 (Tamil Nadu Act 31 of 2008);

(b) "Committee" means a Committee appointed under sub-section (1) of Section 8 of the Act;

(c) "Co-opted Members" means a Member who is Co-opted as a Member for the Committee appointed by the Commission.

**3. Allowance.-** Every Co-opted member of a Committee, if she is not in service of the State or Central Government or in an institution funded by the State or Central Government, shall be entitled to receive an allowance of Rupees One Hundred and Fifty for attending each day of the meeting of the Committee.

**4. Travelling and Daily Allowance.-** Every out-station Co-opted Member of a Committee, if she is not in service of the State or Central Government or in an institution funded by the State or Central Government for attending a meeting of a committee shall be entitled to receive, in addition to the allowance payable under rule 3 travelling allowance and daily allowance as per the orders issued in G.O.(Ms)No.551, Finance(All) Department, dated 3rd November 2004.
