In exercise of the powers conferred by sub-section (4) of Section 32 of the Tamil Nadu Town and Country Planning Act, 1971 (Tamil Nadu Act 35 of 1972), Government in the Order G.O.2T.No.21 Housing and Urban Development [UD4(1)] Department, Dated 24-02-2014 has permitted change of land use of certain survey numbers making the following variation to the Master Plan for the Gummidipoondi Local Planning Area, approved under the said Act and Published in the Housing and Urban Development Department Notification No.II(2)/HOU/610/2000, dated: 07-06-2000, at Page No.295 of Part II Section 2 of the *Tamil Nadu Government Gazette*, dated 7th June 2000.

## VARIATIONS

In the said Master Plan in the "LAND USE SCHEDULE" SERIAL NO. 4 of VILLAGE NUMBER:191, THANDALACHERI under the heading:—

AGRICULTURAL USE ZONE: Survey Numbers, the expression" 113 to 123 & 126 to 130" shall be substituted by the expression" 113 (except 113/1, 2; 114 (except 114/1C, 1D, 2G, 2H1, 2H2, 2H3, 2I, 2J1, 2J2, 2J3), 115 to 122; 123 (except 123/1, 2A, 2B, 2C, 2D, 3A, 3B, 3C, 3D 4, 5, 6A, 6B), 126 to 128, 129 (except 129/1A, 1B, 2, 3A, 3B, 4), 130(except 130/1A, 1B, 1C, 1Ept 1F, 1G, 1H, 1Ipt" and.

Under the heading III Industrial Use Zone, III(b) GENERAL INDUSTRIAL USE ZONE Survey Numbers the expression "113/1, 2, 114/1C, 1D, 2G, 114/2H1, 2H2, 2H3, 2I, 2J1, 2J2, 2J3; 123/1, 2A, 2B, 2C, 2D, 3A, 3B, 3C, 3D, 123/4, 5, 6A, 6B; 129/1A, 1B, 2, 3A, 3B, 129/4; 130/1A, 1B, 1C, 1Ept, 1F, 1G, 1H, 130/1Ipt" shall be inserted after the expression "89, 103".
