**Acquisition of Lands.**

II(2)/HWMP/32/2014.—The Governor of Tamil Nadu having been satisfied that the lands specified in the schedule below have to be acquired for the Highways purpose for the construction of Road over bridge at Km.132/6 of Madurai – Thoothukudi Road (State Highways) in lieu of existing Level Crossing 485 at Railway Km. 651/12-13 at Thoothukudi between Meelavittan and Thoothukudi Railway Stations in Thoothukudi District and it having already been decided that the entire amount of compensation to be awarded for the lands is to be paid out of funds controlled and managed by the Divisional Engineer (Projects), Tirunelveli-7, after considering the cause shown by the owner or other person having interest on such lands as the case may be, do hereby publish the following notice under sub-section (1) of Section 15 of the Tamil Nadu Highways Act 2001 (Tamil Nadu Act 34/2002).

**Proposal for inclusion of the employment in Hand Embroidery and Jari in Part-I of the Schedule to under the Minimum Wages Act.**

**AMENDMENT TO NOTIFICATION**
