No. 136/2014.—In exercise of the powers conferred under Section 13 of Criminal Procedure Code, 1973 (Central Act 2 of 1974) the High Court hereby appoints the following 8 Deputy Tahsildars in Villupuram District, 7 Deputy Tahsildars in Tiruvarur District and 6 Deputy Tahsildars in Nagapattinam District, to undergo Magisterial Training for a period of 120 days from the date of assumption of charge and confers upon them the ordinary powers conferrable under this Code on a Judicial Magistrate to try such cases which were earlier triable and dealt with by an erstwhile Judicial Second Class Magistrate.
